WORKMEN'S COMPENSATION ACT

**Re-Death of – Silon Sucre, late of
26 Wilson Trace, Palo Seco Settlement, Palo Seco
A workman lately employed with RPM Technical Services Ltd.**

Compensation in the above matter having been deposited with me under Section 8 of the Workmen's Compensation Act, persons claiming to be the dependants of the said **Silon Sucre** are hereby required to appear before the Commissioner on **Thursday the 30th** day of **June, 2011 at 10.30 o'clock** in the forenoon at the San Fernando Supreme Court, San Fernando when the Commissioner shall proceed to determine the distribution thereof.

Proof of relationship of *dependants* to the deceased workman will be required by the Commissioner to be furnished by claimants at the enquiry. Such proof to be in the form of certificates of birth and of marriage as in the circumstances be necessary.

A claimant for funeral expenses of the deceased must submit and prove his claim to the Commissioner on or before the **30th day of June, 2011**.
