## APPOINTMENT OF A CUSTOMS AREA/TRANSIT SHED

*(Customs Act, Chap. 78:01)*

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(3) of the said Act, do hereby appoint the place specified in the Schedules hereto to be a Customs Area/Transit Shed for the storage, pending entry for home consumption or export, of general goods, as shall be deposited by or in the Customs Area/Transit Shed of Messrs: International Shipping Limited situated at No. 6–7 Sadoo Trace, El Socorro Extension, San Juan, as indicated and described in the Schedules I and II hereunto:

## SCHEDULE I—CUSTOMS AREA

An area comprising a total of 2362.9 square metres situated at No. 6–7 Sadoo Trace, El Socorro Extension, San Juan. The land and building is owned by Michael Laughlin. The said area is bounded on the north by Narwani's Complex on the south by Sadoo Trace, on the east by lands belonging to Michael Laughlin and on the west by lands owned by Joseph Latchman. This area is completely fenced with solid concrete block walls with razor wire to the top. Included in this area is a Holding Bay for the parking and unloading of containers situated at the western end of the premises and comprising a total of 115.17 square metres.

## SCHEDULE II—TRANSIT SHED

The building is situated in the Customs Area described in Schedule I above. It measures 48.768 metres east to west and 18.138 metres north to south comprising a total of 884.553 square metres. The transit shed is divided into two parts. The first is the storage area located east of the Holding Bay and totaling 550.12 square metres. It is equipped with steel racks three quarters up to the roof for the storage of cargo. The walls are of solid concrete blocks, the floor is of concrete and the roof constructed with steel and galvanize. There is a steel door on the western wall used as the entrance and exit for the container operations.

The second part is the Customs Examination and Delivery Area situated east of the storage area. It is separated from the storage area by a gate made of B.R.C. wire and angle iron. North of this area are washrooms, lunch room and a secured storage bin for high value cargo. North east of this section are the Customs Cashier's Unit, Customs Offices, Kitchen and Washrooms. On the south are offices for International Shipping Ltd. personnel and a reception and client waiting room. The floor is of concrete and there is a steel gate on the southern wall used as the entrance and exit. Above this area is a concrete upper floor housing administrative offices of INTERNATIONAL SHIPPING LTD.

The entire area is properly secured with Closed Circuit Television, Controlled Gates, Barbed Wire Fences, Alarm Systems and twenty-four (24) hour security personnel.
