## REGULATIONS

Made by the Commissioner of Police with the consent of the Minister under section 67(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (SAN JUAN/CHAGUANAS/ENDEAVOUR/LONGDENVILLE/ COUVA/FELICITY/TUNAPUNA/PASEA/VALSAYN SOUTH/ MARACAS-ST. JOSEPH/EDINBURGH 500-MONTROSE CONNECTOR BRIDGE/ST. HELENA) (NO. 2) REGULATIONS, 2011

1. These Regulations may be cited as the Traffic Control Citation (Experimental Scheme) (San Juan/Chaguanas/Endeavour/Longdenville/ Couva/Felicity/Tunapuna/Pasea/Valsayn South/Maracas-St. Joseph/ Edinburgh 500-Montrose Connector Bridge/St. Helena) (No. 2) Regulations, 2011.
2. These Regulations shall have effect from Monday Duration 21st November, 2011 to Sunday 19th February, 2012.

PART I
San Juan
3. Vehicular traffic shall proceed in a northerly and southerly two-way direction on First Street, from the Eastern Main Road to the San Juan traffic Presbyterian Church from 8.00 p.m. on Friday to 2.00 p.m. on Sunday.
4. A motorist shall proceed with his motor vehicle in a westerly One-way direction only on Samaroo Street (west), between Aranguez Road and traffic Boundary Road Extension.
5. A motorist shall not enter with his motor vehicle the following No through areastraffic
(a) First Street, from San Juan Presbyterian Church to Saddle Road from 8.00 p.m. on Friday to 2.00 p.m. on Sunday;
(b) Second Street, from Colda Tinta Avenue to Saddle Road, from 7.00 a.m. to 2.00 p.m. on Saturday and Sunday; and
(c) Colda Tinta Avenue.
6. A motorist shall not park his motor vehicle on First Street, from No parking Church Street to Saddle Road.

(a) the Southern Main Road, between Montrose Junction and Busy Corner; and
(b) Chaguanas Main Road, between Busy Corner and Marie Street.
13. A person shall not enter Orchard Boulevard with a Noentryto maxi-taxi from Rudranath Capildeo Street, from 6.00 a.m. to ${ }^{\text {maxi-taxis }}$ 6.00 p.m. Monday to Saturday.

## PART III

Endeavour
14. A motorist shall not drive his motor vehicle onto the Noentry Endeavour Flyover from the-
(a) north entrance ramp;
(b) south entrance ramp;
(c) north exit ramp whilst proceeding in a southerly direction along the Uriah Butler Highway; and
(d) south exit ramp whilst proceeding in a northerly direction along the Uriah Butler Highway.

Left turn only 16. A motorist driving a motor vehicle west along Chan Ramlal Street from the Uriah Butler Highway shall turn left into the Endeavour Industrial Estate.

17. A motorist shall not park a motor vehicle on-
(a) Chan Ramlal Trace; and
(b) Endeavour Link Road.
18. A motorist shall not turn left onto-
(a) the south entrance ramp whilst proceeding in a westerly direction across the Endeavour Flyover; and
(b) the north entrance ramp whilst proceeding in an easterly direction across the Endeavour Flyover.
19. A motorist shall proceed with his motor vehicle in a-
(a) northerly and then easterly direction on Chan Ramlal Street, between Endeavour Link Road and the Uriah Butler Highway; and
(b) southerly and then westerly direction (within the Endeavour Industrial Estate), along Chan Ramlal Street, from D. Rampersad compound to Shoppers Freezone car park.

20. A motorist shall proceed with his motor vehicle in a-
(a) northerly direction on Apping Street, between Depot Road and Richard Street, from $7.00 \mathrm{a} . \mathrm{m}$. to 9.00 a.m. and 2.00 p.m. to 4.00 p.m. Monday to Friday except on a public holiday; and
(b) westerly direction on Richard Street, between Apping Street and Brasso-Caparo Valley Road, from 7.00 a.m. to 9.00 a.m. and 2.00 p.m to 4.00 p.m. Monday to Friday except on a public holiday.

21. A motorist shall proceed with his motor vehicle in a northerly One-way direction on Victoria Street, Carli Bay River Road and Balisier Street. traffic

25. A motorist shall not enter-
(a) Macoya Road Extension, from Back Street, west of Macoya Road Extention, from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on a public holiday; and
(b) Back Street, from Back Street west, from 6.00 a.m. to $9.00 \mathrm{a} . \mathrm{m}$. and from 3.00 p.m. to $6.00 \mathrm{p} . \mathrm{m}$. Monday to Friday, except on a public holiday.
26. A motorist proceeding north along Macoya Road Extension, shall not turn right at its intersection with Back Street from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on a public holiday.
27. A motorist shall not park his motor vehicle along-
(a) El Dorado Road, between the Eastern Main Road and Parking Lockpat Street; and prohibited
(b) Eastern Main Road, between Caura Royal Road and Goya Street.

## PART VIII

Pasea
28. A motorist shall not park his motor vehicle on-
(a) Pasea Main Road, between Churchill-Roosevelt Highway Parking and Barath Street; prohibited
(b) Jackie Street, from 2.00 p.m. to 6.00 p.m. Monday to Saturday, except on a public holiday; and
(c) Boodoo Street, from 9.00 a.m. to 6.00 p.m. Monday to Saturday, except on a public holiday.

29. A motorist shall proceed with his motor vehicle in a northerly direction on Taguaria Road, between Bimitti Street and the ChurchillRoosevelt Highway from 6.00 a.m. to 9.00 a.m. Monday to Friday One-way except on a public holiday.
30. A motorist shall not enter with his motor vehicle onto-
(a) Taguaria Road from the Churchill-Roosevelt Highway, from No entry 6.00 a.m. to 9.00 a.m. Monday to Friday, except on a public holiday; and
(b) Springvale Road from the Southern Main Road, from 6.00 a.m. to 9.00 a.m. Monday to Friday, except on a public holiday.

PART X
Maracas/St. Joseph
31. A motorist shall proceed with his motor vehicle in-
(a) a southerly direction on Piccadilly Street, between King One-way Street and Richmond Street;
(b) an easterly direction on McLean Street, between Piccadilly Street and Narine Trace; and
(c) a westerly direction on King Street, between Piccadilly Street and Abercromby Street.
32. A motorist shall not enter with his motor vehicle the Eastern Main Road from Charlotte Street, from 6.00 a.m. to 9.00 a.m. Monday

No entry to Friday, except on a public holiday.
33. A motorist shall not park his motor vehicle along Abercromby Street, between the Eastern Main Road and Riverside Road.

Parking

No right turn Circular shall not turn right at its intersection with Clair Street Extension.
36. A motorist proceeding with his motor vehicle south along Edinburgh Boulevard shall not make a "U" Turn at its intersection with Kestrel Boulevard.
No "U" Turn
37. A motorist proceeding with his motor vehicle north along Onyx Circular shall not turn left at its intersection with Clair Street Extension.

PART XI
Edinburgh 500-Montrose Connector Bridge
34. A motorist shall proceed with his motor vehicle in an easterly direction only on Clair Street Extension, between Edinburgh Boulevard and Onyx Circular.
35. A motorist proceeding with his motor vehicle south along Onyx

PART XII
St. Helena
38. A motorist shall not park his motor vehicle on-
(a) Golden Grove Road, from Caroni South Bank Road to Caroni North Bank Road and Golden Grove intersection; and
(b) Caroni South Bank Road for two hundred metres east and west of Golden Grove Road.

PART XIII
General
39. A person who contravenes any of the provisions of these Regulations commits an offence and is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars, and on any subsequent conviction, to a fine of one thousand dollars.
40. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
