REGULATIONS

MADE BY THE MINISTER UNDER SECTION 244 OF THE DEFENCE  
ACT AND LAID BEFORE THE SENATE AND THE HOUSE OF  
REPRESENTATIVES

THE DEFENCE (PENSIONS, TERMINAL AND OTHER GRANTS)  
(AMENDMENT) REGULATIONS, 2011

1. These Regulations may be cited as the Defence (Pensions, <sup>Citation</sup>  
Terminal and Other Grants) (Amendment) Regulations, 2011.

2. In these Regulations, “the Regulations” means the Defence <sup>Interpretation</sup>  
(Pensions, Terminal and Other Grants) Regulations.

3. Regulation 7 of the Regulations is amended, in paragraph (a), by <sup>Regulation 7</sup>  
inserting after the words “such pensionable emoluments” the following <sup>amended</sup>  
words:

“or the sum of—

- (i) one thousand, one hundred and fifty dollars per month, with effect from 1st October, 2006;
- (ii) one thousand, six hundred and fifty dollars per month, with effect from 1st October, 2007;
- (iii) one thousand, nine hundred and fifty dollars per month, with effect from 1st October, 2008; or
- (iv) three thousand dollars per month, with effect from 1st September, 2010,

whichever is the greater”.

4. Regulation 8 of the Regulations is amended, in subregulation (1), <sup>Regulation 8</sup>  
by inserting after the words “pensionable service” the following words: <sup>amended</sup>

“or the sum of—

- (i) one thousand, one hundred and fifty dollars per month, with effect from 1st October, 2006;
- (ii) one thousand, six hundred and fifty dollars per month, with effect from 1st October, 2007;

(iii) one thousand, nine hundred and fifty dollars per month, with effect from 1st October, 2008; or

(iv) three thousand dollars per month, with effect from 1st September, 2010,

whichever is the greater”.

Regulation 9  
amended

5. Regulation 9 of the Regulations is amended in paragraph (a), by inserting after the words “pensionable service” the following words:

“or the sum of—

(i) one thousand, one hundred and fifty dollars per month, with effect from 1st October, 2006;

(ii) one thousand, six hundred and fifty dollars per month, with effect from 1st October, 2007;

(iii) one thousand, nine hundred and fifty dollars per month, with effect from 1st October, 2008; or

(iv) three thousand dollars per month, with effect from 1st September, 2010,

whichever is the greater”.

Regulation 10  
amended

6. Regulation 10 of the Regulations is amended in paragraph (c), subparagraph (i), by inserting after the words “forty-five years” the following words:

“or the sum of—

(A) one thousand, one hundred and fifty dollars per month, with effect from 1st October, 2006;

(B) one thousand, six hundred and fifty dollars per month, with effect from 1st October, 2007;

(C) one thousand, nine hundred and fifty dollars per month, with effect from 1st October, 2008; or

(D) three thousand dollars per month, with effect from 1st September, 2010,

whichever is the greater”.
