REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE  
MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)  
(EL SOCORRO) REGULATIONS, 2011

1. These Regulations may be cited as the Traffic Control Citation  
(Experimental Scheme) (El Socorro) Regulations, 2011.

2. These Regulations shall commence on Monday 18th April, 2011 Duration  
and shall expire on Sunday 17th July, 2011.

3. Motorists shall proceed in—

One-way  
traffic

- (a) a southerly direction on El Socorro Extension Road No. 2,  
between Chan Avenue and Chootoo Trace;
- (b) a westerly direction on Chootoo Trace, between El Socorro  
Extension Road No. 2 and Chanka Trace;
- (c) a northerly direction on Chanka Trace, between Chootoo  
Trace and Chan Avenue; and
- (d) an easterly direction on Chan Avenue, between Chanka  
Trace and El Socorro Extension Road No. 2.

4. Motorists proceeding—

No entry

- (a) south along Chanka Trace, shall not continue south along  
Chanka Trace after Chan Avenue;
- (b) north along El Socorro Extension Road No. 2, shall not  
continue north along El Socorro Extension Road No. 2, after  
Chootoo Trace; and
- (c) east along Parry Lane, shall not enter Chootoo Trace.

5. Motorists proceeding—

No right turn

- (a) west along Chootoo Trace, shall not turn right at its  
intersection with El Socorro Extension Road No. 2;

- (b) south along El Socorro Extension Road No. 2, shall not turn right at its intersection with Chan Avenue;
- (c) north along Chanka Trace, shall not turn right at its intersection with Chootoo Trace;
- (d) east along St. Louis Drive, shall not turn right at its intersection with Chanka Trace;
- (e) east along Rafeek Hosein Trace, shall not turn right at its intersection with Chanka Trace;
- (f) west along Thompson Trace, shall not turn right at its intersection with El Socorro Extension Road No. 2; and
- (g) west along Thompson Trace Extension No. 2, shall not turn right at its intersection with El Socorro Extension Road No. 2.

No left turn

## 6. Motorists proceeding—

- (a) east along Chans Trace, shall not turn left at its intersection with El Socorro Extension Road No. 2;
- (b) east along Thompson Trace Extension No. 1, shall not turn left at its intersection with El Socorro Extension Road No. 2;
- (c) east along Thompson Trace Extension No. 2, shall not turn left at its intersection with El Socorro Extension Road No. 2; and
- (d) west along Chans Trace, shall not turn left at its intersection with Chanka Trace.

Parking prohibited

## 7. Motorists shall not park along—

- (a) El Socorro Extension Road No. 2 from the Churchill-Roosevelt Highway to a point thirty metres south of Chan Avenue; and
- (b) Chootoo Trace from Chanka Trace to a point thirty metres eastward, between the hours of 6.00 a.m. to 9.00 a.m. and 4.00 p.m. to 6.00 p.m. Monday to Friday except on public holidays.

Offence and penalty

8. Any person who contravenes any of the provisions of these Regulations is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars, and on any subsequent conviction, to a fine of one thousand dollars.

9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations, may be removed by the Police and impounded and dealt with in accordance with sections 108 and 109 of the Motor Vehicles and Road Traffic Act.
