THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO has received financing from the Inter-American Development Bank (IDB) and intends to apply part of the proceeds to payments under the project Electronic Government and Knowledge Brokering Program for the Provision of Metro Ethernet/WAN Services for the Ministry of National Security (MNS), Trinidad and Tobago.

The MNS is embarking upon the development of an Enterprise Geographic Information System (eGIS) that will provide a co-ordinated and centralized approach to the Ministry's business activities which rely on a geospatial component. The Ministry's Enterprise Geographic Information System will be a decision-support tool that allows the user to analyse data based on geographic location. The eGIS solution will be scalable, robust and built for high availability to support the various functionalities needed in an end-to-end web GIS system. These include geospatial data modelling, geoprocessing, analysis, web services, mobile applications, desktop applications and development tools.

To enable the eGIS solution, an MNS high capacity network (using wired and wireless technology), high performance network equipment, network server equipment and enterprise geospatial software are being procured.

The services to be provided for this specific component include but are not limited to Metro Ethernet Services (shared or purpose built) which meets the following high level operational brief criteria:

1. The Metro Ethernet service must provide a Layer2 (L2) Switched Ethernet Connection to three (3) core sites [two (2) in Trinidad, one (1) in Tobago] and nine (9) Distribution Sites.
2. The Metro Ethernet service shall operate at a minimum capacity of 40 Mbps at the Distribution Sites and at a minimum capacity of 100 Mbps at the Core Sites.
3. The Metro Ethernet service shall be provided and available on a 99.9% basis.
4. The CPE shall be in the form of an Ethernet Switch with a minimum of 16 x 10/100 Mbps Full Duplex.
5. The Service Provider will provide and guarantee a secure connection and will ensure protection of the data transported via the network between endpoints.

The length of this service is for a minimum period of two (2) years in the first instance.

The Central Tenders Board on behalf of the Ministry of Public Administration now invites sealed bids from eligible bidders to provide the Ministry of National Security with Geospatial Datasets. Bidding will be conducted through international competitive bidding procedures as specified in the Inter-American Development Bank's *Policies for Procurement of Works and Goods financed by the Inter-American Development Bank* (current edition), and is open to all eligible bidders as defined in the policies which can be found at website: <http://www.iadb.org/procurement>.

Proposals must be accompanied by the following where applicable:

- (a) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date for submission of proposals;
- (b) valid Certificate of Compliance issued in accordance with the National Insurance Act.

Bidders are also required to provide a bid security in the sum of one hundred thousand TT dollars (TT\$100,000.00) or equivalent in United States Dollars established by a recognized financial institution with their bid.

An original and six (6) copies of the bids should be placed in separate sealed envelopes clearly marked on the outside: "Tender for the Provision of Metro Ethernet/WAN Services for the Ministry of National Security, Government of the Republic of Trinidad and Tobago (GORTT)".

Envelopes must be addressed to the Chairman, Central Tenders Board, 116, Frederick Street, Port-of-Spain and be deposited in the Brown Tenders Box located in the lobby of the Board's Office not later than 1.00 p.m. (local time) on Thursday 29th August, 2013.

Bids will be opened shortly thereafter. The Bidder or his representative may be present at the opening.
