UPDATED PUBLIC STATEMENT 2012

MINISTRY OF GENDER, YOUTH AND CHILD DEVELOPMENT IN COMPLIANCE WITH SECTION 7 OF THE FREEDOM OF INFORMATION ACT (FOIA) 1999

In accordance with Section 7 of the Freedom of Information Act, 1999 (FOIA) the Ministry of Gender, Youth and Child Development is required by law to publish the following statement which lists the documents and information generally available to the public.

The Act gives members of the public:

- A legal right for each person to access official documents (with exemptions) held by the Ministry of Gender, Youth and Child Development
- A legal right for each person to have official information relating to him/ herself amended where it is incomplete, incorrect or misleading;
- 3. A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA
- A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

Function and Structure of the Ministry of Gender, Youth and Child Development Mission The mission of the Ministry of Gender, Youth and Child Development is to provide effective leadership on issues within its mandate related to gender and development and effective child and youth development, by ensuring evidenced based policy making and implementation of quality services and programmes, planning; monitoring; evaluation and stakeholder collaboration. The Ministry establishes national priorities for children, youth and gender issues to support an enabling environment for the delivery of a broad range of high quality, people centered services from a mix of public, private, regional and international providers.

Vision Statement:

"The Ministry of Gender, Youth and Child Development is a people-centred,

proactive institution that guarantees standards of excellence are achieved by all stakeholders to promote and protect the rights of all citizens, in particular children and young people, while improving the overall human development status of the people of Trinidad and Tobago."

Mandate


The strategic mandate of the Ministry is to contribute to overall human development through the following key areas of work:

- o Gender Development
- o Child Development
- o Youth Development

These areas of work reveal the critical role the Ministry intends to play in enhancing the quality of life of the people of Trinidad and Tobago. Within the context of a constantly evolving socio-economic landscape, the Ministry intends to cement its relevance through the implementation of evidence based policies and programmes, effective use of information and communication technologies and continuous monitoring and evaluation.

Structure

The Ministry of Gender, Youth and Child Development (MGYCD) was established on July 12 2011. It is headed by Senator the Honourable Marlene Coudray, Minister of Gender, Youth and Child Development. The Head Office is located at Tower D, Levels 20-21 International Waterfront Complex, 1A Wrightson Road, Port-of-Spain. As at October 20, 2011 the Ministry comprised a staff of Two Hundred and Eighty-Two (282) persons. This included: Established Officers-One Hundred and Twenty-Six (126), Thirty-Two (32) Short-term Employees, Fourteen (14) Contract Officers and One Hundred and Ten (110) Daily-Rated Workers. The Ministry of Gender, Youth and Child Development is divided into Fourteen (14) Divisions, Five (5) Units/Departments and Nine (9) External Agencies that report to the Minister as depicted in the following Organizational Chart.

Procedure to be followed when accessing a document from the Ministry of Gender, Youth and Child Development

How to Request Information:

General Procedure

Our policy is to answer all requests, both oral and written, for information. However, in order to have the rights given to you by the FOIA (for example the right to challenge a decision if your request for official documents is refused), you must make your request in writing. The applicant must, therefore, complete the appropriate form (Request for Access to Official Documents which is available from the Designated Officer of the Ministry of Gender, Youth and Child Development) for public information that is not readily available to the public.

Addressing Requests

To facilitate prompt handling of your request, please address it to the Designated Officer of the Ministry of Gender, Youth and Child Development see Section 7 (1) (a) (vi).

Details in the Request

Applicants should provide details that will allow for ready identification and location of the records that are being requested. If insufficient information is provided clarification will be sought from the applicant. If you are not sure how to write your request or what details to include, communicate with our Designated Officer.

Requests not handled under the FOIA:

A request under the FOIA will not be processed to the extent that it asks for information, which is readily available to the public, either from this Ministry or from another public authority, for example brochures, pamphlets, reports etc.

Responding to your Request:

Retrieving Documents The Ministry of Gender, Youth and Child Development is required to furnish copies of official documents only when they are in our possession or we can retrieve them from storage. Information stored in the National Archives or another storage center, will be retrieved in order to process your request.

N.B.

Prior to the commencement of the Freedom of Information Act, 1999 old records may have been destroyed. The granting of a request for such documents may therefore be impossible. Various laws, regulations and manuals give the time periods for keeping records before they may be destroyed. For example, The Exchequer and Audit Act, Chap. 69:01

Furnishing Documents An applicant is entitled to copies of information the Ministry has in its possession, custody or power. The Ministry is required to furnish only one copy of a document. If we cannot make a legible copy of a document to be released, we may not attempt to reconstruct it. Instead, we will furnish the best copy possible and note its quality in our reply.

Please note we are not compelled to do the following:

- a. Create new documents. For example, we are not required to write a new program so that a computer will print information in the format you prefer.
- b. Perform research for you.

Time Limits General

The FOIA sets a time limit of thirty (30) calendar days for determination of your request for access to documents. If the Ministry fails to meet this deadline, the FOIA gives you the right to proceed as though your request has been denied. The Ministry will try diligently to comply with the time limit.

If it appears that processing your request may take longer than the statutory

limit, your request will be acknowledged and you will be advised of its status. Since there is a possibility that requests may be incorrectly addressed or misdirected, you may wish to call or write to confirm that we have received the request and to ascertain its status.

Time Allowed

We will determine whether to grant your request for access to information as soon as practicable but no later than thirty (30) days as required by Section 15 of the FOIA. If a decision is taken to grant access to the information requested, you will be permitted to inspect the documents and/or be provided with copies.
