APPOINTMENT OF A PRIVATE WAREHOUSE/CUSTOMS AREA
(*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provision of section 263(2) of the said Act, do hereby appoint the place described in the Schedule hereunder to be a Private Warehouse/Customs Area for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the Private Warehouse of Chemplast (Caribbean) Limited, Lot 10c, Plaisance Park Industrial Estate, Pointe-a-Pierre, Power detergent and such other goods as I may subsequently approve.

SCHEDULE

- (i) An enclosed rectangular area measuring 18 m x 7.5 m x 4.25 m high annexed to the western end of a building measuring 37.2 m x 12 m x 4.25 m high which is bounded on the north by an empty Lot 10B, on the south by a river, on the east by a company named Scaffolding Manufacturers Trinidad Ltd., and on the west by a vacant piece of land and partly by Micro Milling Ltd.
- (ii) The bonded area is separated from the western end of the main building, partly by a painted and plastered brick wall, and framed BRC chain link, which sits atop the wall. The wall also provides windows for the western end of the main building.
- (iii) The southern extremity of the bonded area is made partly of a steel gate with dimensions of 1.2 m wide and 2.13 high flanked on the west by a wall 1.2 m wide and on the east by a wall 5.6 m wide with ventilation blocks and BRC chain link atop the wall and the gate.
- (iv) The western extremity of the bonded area is made of a steel gate 2 m wide and 2.4 m high flanked to the north by a wall 8 m wide and to the south by a wall 8 m wide with ventilation blocks atop the wall and the gate.
- (v) The northern extremity of the bonded area comprise the entrance which is a steel gate 3 m wide and 3 m high, flanked by a wall to the west 1 m wide and a wall to the east 4 m wide. Ventilation blocks sit atop the wall and gate. 2.4 m of that 4 m wide wall is the northern enclosure of a Customs and Excise Office which is 2.4 m long and 2.92 m high.
- (vi) The top of the bonded area is secured by a galvanized ceiling.
