REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE  
MINISTER OF WORKS AND INFRASTRUCTURE UNDER SECTION 67(1)  
OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) [ROUTE  
AREA (1) MAXI-TAXI STAND] (BROADWAY, PORT-OF-SPAIN)  
REGULATIONS, 2013

1. These Regulations may be cited as the Traffic Control<sup>Citation</sup>  
(Experimental Scheme) [Route Area (1) Maxi-Taxi Stand] (Broadway,  
Port-of-Spain) Regulations, 2013.

2. These Regulations shall commence on Monday 23rd December, <sup>Duration</sup>  
2013 and expire on Saturday 22nd March, 2014.

3. In these Regulations, “Route Area (1)” means the route area <sup>Interpretation</sup>  
specified in the Fourth Schedule of the Maxi-Taxi Regulations. <sup>Chap. 48:53</sup>

4. (1) No more than ten maxi-taxis that ply Route Area (1) shall <sup>Maxi-taxi</sup>  
park on the western side of Broadway facing north, nine metres south <sup>stand</sup>  
of Independence Square South as marked.

(2) Subject to subregulation (1), maxi-taxi drivers shall only park  
between the hours of 6.00 p.m. and 5.00 a.m. at the maxi-taxi stand.

5. Maxi-taxi drivers plying Route Area (1) shall— <sup>Entry and exit</sup>

- (a) enter South Quay from the eastbound lane of Wrightson Road to proceed in an easterly direction, turn left onto Broadway and proceed in a northerly direction into the maxi-taxi stand; and
- (b) exit the maxi-taxi stand by turning left onto Independence Square South and proceed in a westerly direction onto Wrightson Road.

6. Maxi-taxi drivers plying Route Area (1) between the hours of <sup>Left turn</sup>  
6.00 p.m. and 5.00 a.m. shall turn left onto—

- (a) St. Vincent Street from Independence Square South;
- (b) South Quay from St. Vincent Street; and
- (c) Broadway from South Quay.

- No entry            7. Maxi-taxi drivers plying Route Area (1) between the hours of 6.00 p.m. and 5.00 a.m. shall not enter—
- (a) Chacon Street from South Quay;
  - (b) Edward Street from Independence Square South;
  - (c) Abercromby Street from Independence Square South;
  - (d) South Quay from its intersection with Broadway in order to proceed in an easterly direction; and
  - (e) Independence Square North from Independence Square South.
- Offence and penalty        8. Any person who contravenes these Regulations is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars and on any subsequent conviction to a fine of one thousand dollars.
- Removal and impounding of vehicles unlawfully parked        9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
