#### **Explanatory Note**

The Bill seeks to provide for the service of Trinidad and Tobago for the financial year ending September 30, 2015 by authorizing the issue from the Consolidated Fund of the sum of fifty-seven thousand, nine hundred and seven million, three hundred and sixty-six thousand, five hundred and forty-three dollars (\$57,907,366,543).

#### **BILL**

An AcT to provide for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2015

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:

1. This Act may be cited as the Appropriation  $_{\hbox{\scriptsize Short title}}$  (Financial Year 2015) Act, 2014.

Issue from the Consolidated Fund authorized 2. (1) The issue from the Consolidated Fund of the sum of fifty-seven thousand, nine hundred and seven million, three hundred and sixty-six thousand, five hundred and forty-three dollars (\$57,907,366,543) is authorized for meeting expenditure for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2015, under the Heads of Expenditure specified in the First Column of the Schedule.

Schedule

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of fifty-seven thousand, nine hundred and seven million, three hundred and sixty-six thousand, five hundred and forty-three dollars (\$57,907,366,543) for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2015.

Commencement

**3.** This Act shall come into force on the 1st day of October, 2014.
