TRINIDAD AND TOBAGO RACING AUTHORITY

AMENDMENTS TO THE RULES OF RACING

THE TRINIDAD AND TOBAGO RACING AUTHORITY wishes to advise of the following amendments to the Rules of Racing:

Rule 20—Starter and Starting—

10. Except in cases of emergency, every horse shall be started from an approved Starting Gate by the Starter. If the doors at the front of the Starting Gate stall should not open due to mechanical failure or a malfunction of the Starting Gate, when the Starter dispatches the field, or should a horse's chances be compromised as a result of the foregoing, or should a horse not be in the Starting Gate Stall when the field is dispatched, thereby causing such horse to be left, the starter shall immediately report such fact to the stewards, and the stewards may declare such left horse to be a non-starter.

The above amendment to the Rules of Racing was approved at a meeting of the Trinidad and Tobago Racing Authority on Tuesday 12th August, 2014.
