ORDER

Before the Honourable MR. JUSTICE JAMES C. ABOUD

Dated: 5th August, 2014.

Upon Reading the Claimant's Fixed Date Claim filed on 7th July, 2014 together with the affidavit and supplemental affidavits of Cecil H. A. Pope respectively sworn and filed on 7th, 11th and 23rd July, 2014 with the exhibits annexed thereto.

And upon this matter being dealt with in chambers without a hearing and being deemed fit for vacation business.

And upon the Claimant having paid all outstanding fines ordered by the Disciplinary Committee of the Law Association and substantially complied with the order to return his former client's file in Disciplinary Proceedings No. 37 of 2009, Cynthia Winston v Cecil Pope, and additionally having paid annual subscriptions and contributions to the Compensation Fund for the years 1999–2000; 2000–2001; 2001–2002; 2002–2003; 2003–2004; 2004–2005; 2005–2006; 2006–2007; 2007–2008; 2008–2009 (for which he alleges no Practising Certificates were issued) and; further having paid annual subscriptions and his contribution to the Compensation Fund for the years 2010–2011; 2011–2012; 2012–2013; 2013–2014 (which said payments were not paid during the law terms for which they were due, and for which Practising Certificates were not issued).

It is hereby ordered that—

1. The Court declares that the suspension of the Claimant which was occasioned on 6th June, 2014 by insertion of an annotation into the Roll of Attorneys-at-law and further published in the *Trinidad and Tobago Gazette* be and the same is hereby lifted and that all consequent procedures be undertaken to give effect to such lifting;
2. The Court orders that the Registrar of the Supreme Court of Judicature do issue to the claimant a Practising Certificate for the law terms 1999–2000; 2000–2001; 2001–2002; 2002–2003; 2003–2004; 2004–2005; 2005–2006; 2006–2007; 2007–2008; 2008–2009; 2010–2011; 2011–2012; 2012–2013; 2013–2014 and have the name of the Claimant restored to the Roll of Attorneys-at-law to practice law in this jurisdiction and have the suspension of the Claimant lifted and that the Registrar do re-enter the name of the Attorney-at-law to on the Roll, and have such notice of lifting of the suspension and re-entering of the Roll published in the *Gazette* forthwith, the Claimant being an Attorney-at-law who has, for twelve (12) months or more, not held a valid practising certificate, who has been suspended from practice and had his name struck off the Roll, and who having paid his dues requests that his name be restored to the Roll.
3. The length of notice of six (6) weeks to the Registrar of Supreme Court of Judicature of this application provided for in section 24(1) of the Legal Profession Act, 1986, be and is hereby abridged to today's date.
4. This order is made without prejudice to the right of the Registrar of the Supreme Court or any person to complain about any non-compliance by the Claimant with the provisions of the Legal Profession Act, 1986 during any law term for which the Claimant is alleged to have practised law without a Practising Certificate having been issued to him or practised law without having paid his annual subscription or his contribution to the Compensation Fund.
