### ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

# THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA FETE) ORDER, 2014

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Fete) Order, 2014.
- 2. This Order has effect between the hours of 4.00 p.m. to midnight Duration on Saturday 10th May, 2014 and 9.00 a.m. to midnight on Sunday 11th May, 2014.
- 3. (1) On Saturday 10th May, 2014, no person driving a motor Vehicular vehicle shall drive onto—
  - (a) the San Fernando-Siparia-Erin Road from—
    - (i) Edward Street;
    - (ii) Coora Road; and
    - (iii) De Gannes Lane; and
  - (b) George Street from—
    - (i) Daisy Voisin Street;
    - (ii) Coora Road; and
    - (iii) Edward Street.
- (2) On Saturday 10th May, 2014, a person driving a motor vehicle and entering Siparia from Erin and proceeding to San Fernando shall drive—
  - (a) south onto La Pastora Street, east onto Victoria Street, north onto Allies Street and east onto the San Fernando-Siparia-Erin Road; or
  - (b) north onto the Fyzabad-Oropouche Road, east onto Gambal Street, south onto Grell Street and east onto the San Fernando-Siparia-Erin Road.
- (3) On Sunday 11th May, 2014, no person driving a motor vehicle shall drive on—
  - (a) Allies Street, between High Street and Bermudez Trace;
  - (b) Daisy Voisin Street, between High Street and Victoria Street;
  - (c) Coora Road, between High Street and Victoria Street;
  - (d) Edward Street;
  - (e) High Street, between Grell Street and La Pastora Street;

- (f) George Street;
- (g) Mary Street; and
- (h) Station Street, between Victoria Street and Mary Street.

## Parking prohibited

- 4. On Sunday 11th May, 2014, no person driving a motor vehicle shall park on—
  - (a) Grell Street;
  - (b) Gambal Street;
  - (c) Fyzabad-Oropouche Road, between High Street and Gambal Street;
  - (d) Victoria Street, between Allies Street and La Pastora Street;
  - (e) Allies Street, between Bermudez Trace and Victoria Street;
  - (f) La Pastora Street; and
  - (g) De Gannes Lane.

#### Traffic routes

- 5. A person driving a motor vehicle and entering—
  - (a) Siparia from Penal shall drive along Grell Street, onto Gambal Street and onto the Fyzabad-Oropouche Road;
  - (b) Penal from Siparia shall drive along the Fyzabad-Oropouche Road, onto Gambal Street, onto Grell Street and onto the San Fernando-Siparia-Erin Road;
  - (c) Siparia from Mendez Village and proceeding to San Fernando, shall drive along Coora Road, turn east onto Victoria Street, onto Allies Street, onto Bermudez Trace and east onto the San Fernando-Siparia-Erin Road; and
  - (d) Siparia from Mendez Village and proceeding to Erin shall drive along Coora Road, turn west onto Victoria Street, onto Station Street and west onto the San Fernando-Siparia-Erin Road.

Removal and impounding of vehicles unlawfully parked 6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
