THE SPIRITS AND SPIRIT COMPOUNDS ACT, CHAP. 87:54

REGULATIONS

Made by the Minister under section 55A of the Spirits and Spirit Compounds Act

THE WAREHOUSING OF SPIRITS (AMENDMENT) REGULATIONS, 2014

- 1. These Regulations may be cited as the Warehousing of Spirits Citation (Amendment) Regulations, 2014.
- 2. In these Regulations, "the Regulations" means the Warehousing Interpretation of Spirits Regulations.

 Chap. 87:54
- 3. Regulation 5(1) of the Regulations is amended by deleting Regulation 5 paragraphs (*a*) and (*b*) and substituting the following paragraphs:

 amended
 - "(a) where more than one officer is in charge, the maximum payable in respect of the senior officer shall be—
 - (i) eight thousand, one hundred and fifty-seven dollars per month with effect from 1st January, 2008;
 - (ii) eight thousand, two hundred and thirty-nine dollars per month with effect from 1st January, 2009;
 - (iii) eight thousand, four hundred and four dollars per month, with effect from 1st January, 2010;
 - (iv) eight thousand, seven hundred and forty dollars per month with effect from 1st January, 2011;

and in respect of each other officer-

- (v) seven thousand, four hundred and twenty-two dollars per month with effect from 1st January, 2008";
- (vi) seven thousand, four hundred and ninety-six dollars per month with effect from 1st January, 2009;
- (vii) seven thousand, six hundred and forty-six dollars per month with effect from 1st January, 2010; and

- (viii) seven thousand, nine hundred and fifty-two dollars per month with effect from 1st January, 2011; and
- (b) where only one officer is in charge, the maximum amount payable shall be—
 - (i) seven thousand, four hundred and twenty-two dollars per month with effect from 1st January, 2008:
 - (ii) seven thousand, four hundred and ninety-six dollars per month with effect from 1st January, 2009:
 - (iii) seven thousand, six hundred and forty-six dollars per month with effect from 1st January, 2010; and
 - (iv) seven thousand, nine hundred and fifty-two dollars per month with effect from 1st January, 2011.".

Regulation 6 amended

- 4. Regulation 6(2) of the Regulations is amended—
 - (a) in paragraph (a), by deleting the words "one hundred and ninety-nine dollars and fourteen cents with effect from 1st January, 2005" and substituting the words "two hundred and forty-four dollars and one cent with effect from 1st January, 2008";
 - (b) in paragraph (b), by deleting the words "two hundred and five dollars and twelve cents from 1st January, 2006; and" and substituting the words "two hundred and forty-six dollars and forty-four cents with effect from 1st January, 2009";
 - (c) in paragraph (c), by deleting the words "two hundred and thirty-five dollars and eleven cents with effect from 1st January, 2007," and substituting the words "two hundred and fifty-one dollars and thirty-eight cents with effect from 1st January, 2010; and"; and
 - (d) by inserting after paragraph (c), the following paragraph:
 - " (*d*) two hundred and sixty-one dollars and forty-four cents with effect from 1st January, 2011,".
