NOTICE is hereby given that BP Trinidad and Tobago LLC (BPTT) is desirous of establishing the Juniper Platform and installing a subsea production system inclusive of five (5) subsea development wells, import flexible multiphase flowlines, umbilical and a 26-inch diameter subsea pipeline, 10 km in length, within the Corallita and Lantana Fields located offshore the south-east coast of Trinidad and that this project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order (as amended), thus requiring a Certificate of Environmental Clearance pursuant to section 35 of the Environmental Management Act, Chap. 35:05 ("the Act"). BPTT has applied for a Certificate of Environmental Clearance ("the Certificate") from the Environmental Management Authority ("the Authority") for this project.
