Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (VIII AMERICAS COMPETITIVENESS FORUM) ORDER, 2014

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (VIII Americas Competitiveness Forum) Order, 2014.
 - 2. This Order shall have effect in—

Duration

- (a) Port-of-Spain, from 12.01 a.m. on Monday 6th October, 2014 to midnight on Saturday 11th October, 2014; and
- (b) San Fernando, from 12.01 a.m. on Wednesday 8th October, 2014 to midnight on Wednesday 8th October, 2014.

PART I

PORT-OF-SPAIN

- 3. (1) Vehicular traffic and parking are prohibited from 3.00 p.m. to Road closed midnight on Friday 10th October, 2014 on—
 - (a) Frederick Street, between Duke Street and Queen Street;
 - (b) Abercromby Street, between Duke Street and Queen Street;
 - (c) St. Vincent Street, between Duke Street and Queen Street; and;
 - (d) Sackville Street, between Edward Street and St. Vincent Street.
- (2) Vehicular traffic and parking are prohibted on Hart Street from 12.01 a.m. on Wednesday 8th October, 2014 to midnight on Saturday 11th October, 2014.
- 4. From 3.00 p.m. to midnight on Friday 10th October, 2014, Traffic motorists proceeding—
 - (a) south along Frederick Street shall turn west onto Duke Street:

- (b) north along Abercromby Street shall turn west onto Queen Street:
- (c) south along St. Vincent Street shall turn west onto Duke Street;
- (d) east along Sackville Street shall turn north onto Edward Street; and
- (e) west along Queen Street shall turn north onto Edward Street.

Parking prohibited

5. Parking is prohibited—

- (a) on Dock Road from midnight on Monday 6th October, 2014 to midnight on Saturday 11th October, 2014; and
- (b) from 3.00 p.m. to midnight on Friday 10th October, 2014;
 - (i) Keate Street, between St. Vincent Street and Frederick Street;
 - (ii) Hart Street, between St. Vincent Street and Frederick Street;
 - (iii) Duke Street, between Frederick Street and St. Vincent Street; and
 - (iv) Queen Street, between Frederick Street and St. Vincent Street.

Taxi stands

- 6. Taxis plying for hire shall operate as follows:
 - (a) St. Ann's taxi drivers shall ply for hire on the northern side of Independence Square North, between Chacon Street and Frederick Street; and
 - (b) St. James taxi drivers shall ply for hire on the northern side of Independence Square North, between Frederick Street and Henry Street.

PART II

San Fernando

Parking prohibited

- 7. From 12.01 a.m. on Wednesday 8th October, 2014 to midnight on Wednesday 8th October, 2014 parking is prohibited on—
 - (a) Abattoir Road; and
 - (b) Todd Street, between Scott Street and Rienzi Kirton Highway.

8. Without prejudice to any other liability incurred by the $_{\text{Removal}}$ and commission of a summary offence, vehicles found parked in $_{\text{of}}^{\text{impounding}}$ contravention of this Order may be removed by the Police and $_{\text{unlawfully}}^{\text{unlawfully}}$ impounded and dealt with in accordance with section 108 of the Motor $_{\text{parked}}^{\text{parked}}$ Vehicles and Road Traffic Act.
