THE FINANCE (VARIATION OF APPROPRIATION) (FINANCIAL YEAR 2015) BILL, 2016

Explanatory Note

(These notes form no part of the Bill but are intended only to indicate its general purport)

The Bill seeks to vary the appropriation of the sum the issue of which was authorized by the Appropriation (Financial Year 2015) Act, 2014 (Act No. 16 of 2014) and varied by the Finance (Variation of Appropriation) (Financial Year 2015) Act, 2015 (Act No. 9 of 2015) and to authorize the utilization of any sums accruing from a reduction in expenditure under a certain Head of Expenditure for the purpose of meeting liability incurred through the increase in expenditure under another Head.

ENACTED by the Parliament of Trinidad and Tobago as $_{\mbox{\scriptsize Enactment}}$ follows:

1. This Act may be cited as the Finance (Variation of Short title Appropriation) (Financial Year 2015) Act, 2016.

Interpretation

Act No. 16 of 2014

2. In this Act, "the Appropriation Act, 2015" means the Appropriation (Financial Year 2015) Act, 2014 as amended by the Finance (Variation of Appropriation) (Financial Year 2015) Act, 2015.

Act No. 9 of 2015

Increase in Head of Expenditure Schedule 3. The sum appropriated to the Head of Expenditure specified in the First Column of Part I of the Schedule to this Act by the Appropriation Act, 2015 is increased by the amount specified in the Second Column of that Part.

Reduction in Head of Expenditure Schedule 4. The sum appropriated to the Head of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2015 is reduced by the amount specified in the Second Column of that Part.

Sum appropriated in respect of Head specified in Part II may be utilized Schedule

Chap. 69:01

5. The sum appropriated in respect of the Head of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2015 and not utilized at the commencement of this Act may be utilized, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Head of Expenditure specified in the First Column of Part I of the Schedule to this Act.
