NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON AN APPLICATION FOR A CERTIFICATE OF ENVIRONMENTAL CLEARANCE WHICH REQUIRES AN ENVIRONMENTAL IMPACT ASSESSMENT SUBMITTED BY DENOVO ENERGY LIMITED

(Made under section 35 of the Environmental Management Act)

NOTICE is hereby given that DeNovo Energy Limited is desirous of developing Blocks 1(a) and 1(b) to include the installation of four (4) unmanned production platforms, drilling of one (1) appraisal, two (2) exploration and fifteen (15) production wells, within the Gulf of Paria and installation of 66.1 km natural gas pipeline (64.6 km subsea and 1.5 km onshore crossing at the Point Lisas shoreline), West Coast, Trinidad. This project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order (as amended) thus requiring a Certificate of Environmental Clearance pursuant to section 35 of the Environmental Management Act, Chapter 35:05 ("the Act"). DeNovo Energy Limited has applied for a Certificate of Environmental Clearance ("the Certificate") from the Environmental Management Authority ("the Authority") for this project.
