**TOBAGO HOUSE OF ASSEMBLY ELECTIONS, 2017  
COMMENCEMENT OF ELECTORAL REGISTRATION**

Members of the public including persons already registered, are hereby notified that under Section 30 of the Representation of the People Act Chap. 2:01, His Excellency, The President of the Republic of Trinidad and Tobago has issued a Proclamation, which fixed 19th December, 2016 as the date for the commencement of an Electoral Registration in the twelve (12) Electoral Districts in Tobago.

In accordance with the said Section 30, the Electoral Registration is being conducted at the Registration Area Office and the Registration Area Sub-Office (as indicated hereunder) up to and including **Friday 30<sup>th</sup> December, 2016.**

**Please Note:** The above electoral registration period excludes the public holidays on Sunday 25th, Monday 26th and Tuesday 27th December, 2016.

The purpose of the exercise is to facilitate those persons who:

- (1) have attained the age of 18 years and over, but who have not been registered as electors;

- (2) have been registered as electors but have changed their addresses and have not yet notified the Registration Officer of such change of addresses.
- (3) have been registered as electors and have changed their names because of marriage or otherwise, but their previous names appear on the Preliminary List of Electors;
- (4) have been registered as electors but their names do not appear on the Preliminary List of Electors.

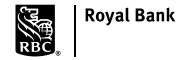
