1. The Government of Trinidad and Tobago listed a \$1,017.978M 7 year 8.00% Fixed Rate Bond due 2014 ("the GORTT Bond") on the Trinidad and Tobago Stock Exchange Limited Official Listing;

#### **AND WHEREAS:**

2. The Central Bank of Trinidad and Tobago confirmed that the GORTT Bond matured and all principal and final interest payments were made to bond holders on April 28, 2014 by letter dated July 4, 2014;

- The Trinidad and Tobago Stock Exchange Limited ("TTSE") submitted an application together with the prescribed fee for the de-listing of the GORTT Bond from its Official Listing on July 10, 2014;
- 4. Section 45 (1) of the Securities Act 2012 ("SA 2012") prescribes that no securities exchange shall de-list a security admitted for quotation by it unless it pays the prescribed fees and obtains an order from the Commission authorizing the delisting;
- The Board of Commissioners delegated its authority to approve the delisting applications from the TTSE, to the Chief Executive Officer where the de-listing does not adversely affect the rights of persons and are essentially procedural, by Order dated March 27, 2014
- 6. The Chief Executive Officer approved the de-listing of the GORTT Bond effective March 19, 2015

#### AND UPON:

- The Board of Commissioners considering that the Chief Executive Officer acted in accordance with the delegated authority conferred on him in approving the delisting of the GORTT Bond;
- 8. The Commission being satisfied that no hearing is required Section 159 (1) of the SA 2012 as this Order is essentially procedural and does not adversely affect the rights; and

- 3. By letter dated February 25, 2013, Cimco PCC Limited confirmed that the Fund was never marketed or sold to customers in Trinidad and Tobago and that there are no Trinidad and Tobago nationals who are investors in the Fund;
- 4. By letter dated February 25, 2013, Cimco PCC Limited submitted an application for its de-registration as a Reporting Issuer to the Commission; and
- 5. Notices of Cimco PCC Limited's intention to be de-registered were published in Trinidad and Tobago in October 2015 to the satisfaction of the Commission and no objections or concerns have been raised with respect to the de-registration.

#### **AND UPON:**

- The Board of Commissioners considering the facts pertaining to Cimco PCC Limited's failure to comply with several continuous disclosure requirements as a Reporting Issuer over the period January 2013 to November 2015;
- The Board of Commissioners considering an application from Cimco PCC Limited for its de-registration as a Reporting Issuer dated February 25, 2015;
- 3. The Board of Commissioners being satisfied that making an Order for the deregistration of Cimco PCC Limited as a Reporting Issuer under section 71 (1) (b) of the Securities Act 2012 (the Act) will not adversely affect the rights of any person;

- UTC registered with the Commission the UTC Growth and Income Fund (GIF), a Collective Investment Scheme;
- 3. By way of letter dated November 17, 2015 the UTC informed the Commission of a proposed acquisition, by its GIF of additional shares in Pan West LLC;
- The proposed acquisition would effectively increase GIF's holding in Pan West LLC from 10% to 33.3%;
- 5. Guideline Number 19 of the Commission's Guidelines for Collective Investment Schemes ("CIS Guideline") provides, inter alia,:
  - "A collective investment scheme shall not (a) purchase a security of an issuer if, immediately after the purchase, the collective investment scheme would hold securities representing more than ten percent of the votes attaching to the outstanding voting securities of that issuer, or the outstanding equity securities of that issuer"; and
- By way of letter dated November 17, 2015, the UTC has applied to the Commission for the UTC Growth and Income Fund to be exempted from CIS Guideline Number 19.

#### AND UPON:

 The Board of Commissioners considering the application from UTC for an exemption from CIS Guideline Number 19 and comments of the Central Bank of Trinidad and Tobago;

8. The Board of Commissioners concluding that it is not contrary to the public interest to make an Order exempting the UTC from the requirement to comply with CIS Guideline Number 19 in accordance with Section 155(1A) (c) of the Securities Act 2012 ("the Act"); and

9. The Board of Commissioners being satisfied that this Order is essentially procedural and would not affect the rights or interest of any party and therefore does not require a hearing in accordance with Section 159(10) of the Act.

#### IT IS HEREBY ORDERED THAT:

- I. The UTC is exempt from CIS Guideline Number 19, specifically in relation to the Trinidad and Tobago Unit Trust Corporation Growth and Income Fund's proposed acquisition of 33.3% of Pan West LLC;
- II. This Order shall be published in the Trinidad and Tobago Gazette and on the Commission's website; and
- III. This Order shall be effective from December 08, 2015.
