Practice- Non-contentious (or common form) probate business - Applications at the Probate Registry- Filing of documents- Filing Forms to accompany documents

Given the upgrade to the operations at the Probate Registry it has become necessary to develop a system through which documents can be tracked at the time of lodging and the filing of an application to ensure efficient processing and disposition. The upgrade to operations would also facilitate improved communication with Attorneys-at-law regarding their applications.

In light of the above and with a view to the continued promotion of efficient administration the Honourable Chief Justice issues the following directions with effect from March 7th 2016:

1. This Practice Direction applies to non-contentious (or common form) probate business.
2. So far as is practicable, every document prepared for use in any Probate Registry must be on "letter size" paper; approximately 11 inches long by 8.5 inches wide. Margins of 1" (25 mm) must be left at top and bottom and of 1.5" (38 mm) at each side
3. Every document to be filed at any Probate Registry must be headed with the title of the estate proceedings and-
 - a. a description of the document; and
 - b. be endorsed at the top right hand corner with the following particulars of the filing attorney-at-law.
 - i. name;
 - ii. firm name;
 - iii. bar number;
 - iv. address;
 - v. telephone and fax numbers; and
 - vi. e-mail address.

4. Every new application pertaining to non-contentious (or common form) probate business to be filed at any Probate Registry of the Supreme Court of Judicature of Trinidad and Tobago must be accompanied by a completed Form A-Information Filing Form for a New Application.
5. Every existing application pertaining to non-contentious (or common form) probate business to be filed at any Probate Registry of the Supreme Court of Judicature of Trinidad and Tobago must be accompanied by a completed Form B- Information Filing Form for an Existing Application.
6. Every document requiring the approval of the Registrar of the Supreme Court or any request for a search of previous applications and the depository for Wills lodged at any Probate Registry of the Supreme Court of Judicature of Trinidad and Tobago pertaining to non-contentious (or common form) probate business must be accompanied by a completed Form C- Information Filing Form for a Document Lodged.

Instructions for the completion of the respective Information Filing Forms are contained in the forms hereto annexed as Forms A, B and C respectively.
