REGULATIONS

MADE BY THE MINISTER UNDER SECTION 55A OF THE SPIRITS AND  
SPIRIT COMPOUNDS ACT

THE WAREHOUSING OF SPIRITS (AMENDMENT)  
REGULATIONS, 2016

1. These Regulations may be cited as the Warehousing of Spirits Citation  
(Amendment) Regulations, 2016.

2. In these Regulations, “the Regulations” means the Warehousing Interpretation  
of Spirits Regulations. Chap. 87:54

3. Regulation 5(1) of the Regulations is amended by deleting Regulation 5  
paragraphs (a) and (b) and substituting the following paragraphs: amended

“(a) where more than one officer is in charge, the maximum  
payable—

(i) in respect of the senior officer shall be—

(A) nine thousand, two hundred and forty  
dollars per month with effect from  
1st January, 2011;

(B) nine thousand, six hundred and ten  
dollars per month with effect from 1st  
January, 2012; and

(C) ten thousand, one hundred and eighty-  
seven dollars per month with effect from  
1st January, 2013; and

(ii) in respect of each other officer shall be—

(A) eight thousand, four hundred and  
twenty-one dollars per month with effect  
from 1st January, 2011;

(B) eight thousand, seven hundred and fifty-  
eight dollars per month with effect from  
1st January, 2012; and

(C) nine thousand, two hundred and eighty-  
three dollars per month with effect from  
1st January, 2013; and

- (b) where only one officer is in charge, the maximum amount payable shall be—
- (i) eight thousand, four hundred and twenty-one dollars per month with effect from 1st January, 2011;
  - (ii) eight thousand, seven hundred and fifty-eight dollars per month with effect from 1st January, 2012; and
  - (iii) nine thousand, two hundred and eighty-three dollars per month with effect from 1st January, 2013.”.

Regulation 6  
amended

4. Regulation 6(2) of the Regulations is amended by deleting paragraphs (a) to (d) and substituting the following paragraphs:

- “(a) two hundred and seventy-six dollars and eighty-five cents with effect from 1st January, 2011;
- (b) two hundred and eighty-seven dollars and ninety-three cents with effect from 1st January, 2012; and
- (c) three hundred and five dollars and nineteen cents with effect from 1st January, 2013.”.

Regulation 6A  
inserted

5. The Regulations are amended by inserting, after regulation 6, the following regulation:

“Exemption  
from  
retrospective  
increase

6A. Notwithstanding regulations 5 and 6, a warehouse-keeper of a private warehouse, is exempt from paying any increase of the sum payable under regulations 5 and 6 which comes into effect as a result of an amendment to the Regulations that is published after the date on which the supervision of the private warehouse is provided or exercised.”.
