ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA FETE) ORDER, 2016

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Fete) Order, 2016.
- 2. This Order shall have effect from 6.00 p.m. on Saturday Duration 16th April, 2016 to 2.00 a.m. on Sunday 17th April, 2016 and from 10.00 a.m. to 11.00 p.m. on Sunday 17th April, 2016.
- 3. (1) Vehicular traffic is prohibited from entering the Vehicular San Fernando-Siparia-Erin Road from—
 - (a) Edward Street;
 - (b) Coora Road;
 - (c) De Gannes Lane;
 - (d) Allies Street; and
 - (e) Daisy Voisin Street.
 - (2) Vehicular traffic is prohibited on—
 - (a) George Street, between Coora Road and La Pastora Street; and
 - (b) San Fernando-Siparia-Erin Road, between Grell Street and La Pastora Street.
- 4. Vehicular traffic and parking are prohibited between 10.00 a.m. Vehicular and 2.00 p.m. on Sunday 17th April, 2016, on—
 - (a) Allies Street, between San Fernando-Siparia-Erin Road prohibited and Bermudez Trace;
 - (b) Daisy Voisin Street, between San Fernando-Siparia-Erin Road and Victoria Street;
 - (c) Coora Road, between San Fernando-Siparia-Erin Road and Victoria Street;
 - (d) Edward Street;
 - (e) San Fernando-Siparia-Erin Road, between Grell Street and La Pastora Street;
 - (f) George Street;
 - (g) Mary Street; and
 - (h) Station Street, between Victoria Street and Mary Street.

Parking prohibited

- 5. Parking is prohibited on—
 - (a) Grell Street;
 - (b) Gambal Street;
 - (c) Fyzabad-Siparia Road, between San Fernando-Siparia-Erin Road and Gambal Street;
 - (d) Victoria Street, between Allies Street and La Pastora Street;
 - (e) Allies Street, between Bermudez Trace and Victoria Street;
 - (f) La Pastora Street;
 - (g) De Gannes Lane; and
 - (h) Bermudez Trace.

Traffic routes

- 6. (1) A driver approaching Siparia from Penal along the San Fernando-Siparia-Erin Road, shall proceed north onto Grell Street, north-west onto Gambal Street, and onto the Fyzabad-Siparia Road.
- (2) A driver approaching Siparia from Erin along the San Fernando-Siparia-Erin Road, and proceeding towards San Fernando, shall proceed north onto the Fyzabad-Siparia Road, north-east onto Gambal Street, south onto Grell Street, and east onto the San Fernando-Siparia-Erin Road.
- (3) A driver approaching Siparia from Mendez Village along Coora Road, and proceeding towards San Fernando, shall proceed east onto Victoria Street, north onto Allies Street, east onto Bermudez Trace, and east onto the San Fernando-Siparia-Erin Road.
- (4) A driver approaching Siparia from Mendez Village along Coora Road and proceeding towards Erin, shall proceed west onto Victoria Street, south-west onto Station Street, north-west onto Railway Street and west onto the San Fernando-Siparia-Erin Road.
- (5) A driver approaching Siparia from Fyzabad along the Fyzabad-Siparia Road, and proceeding towards Erin, shall proceed west onto the San Fernando-Siparia-Erin Road.
- (6) A driver approaching Siparia from Fyzabad along the Fyzabad-Siparia Road, and proceeding towards San Fernando, shall proceed north-west onto Gambal Street, south onto Grell Street and east onto the San Fernando-Siparia-Erin Road.
- (7) A driver approaching Siparia from Erin along the San Fernando-Siparia-Erin Road, and proceeding towards Mendez Village, shall proceed south-east onto Railway Street, north-east onto Station Street, east onto Victoria Street and south onto Coora Road.

- (8) A driver approaching Siparia from Penal along the San Fernando-Siparia-Erin Road, and proceeding towards Mendez Village, shall proceed south onto Bermudez Trace, south onto Allies Street, west onto Victoria Street, and south onto Coora Road.
- 7. The following Taxi and Maxi-Taxi Stands shall be relocated as Taxi and follows:

 Maxi-taxi stands
 - (a) the Erin Taxi Stand, to the entrance to the Siparia Market;
 - (b) the Penal Taxi Stand, to the Daisy Voisin Hub; and
 - (c) the Penal and San Fernando Maxi-Taxi Stand, to the Daisy Voisin Hub.
- 8. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in impounding contravention of this Order may be removed by a member of the unlawfully Police Service and impounded and dealt with in accordance with parked section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
