Made by the Commissioner of Police under Section 68(1) of the MOTOR VEHICLES AND ROAD TRAFFIC ACT

# THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (TOBAGO JAZZ EXPERIENCE) ORDER, 2016

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Tobago Jazz Experience) Order, 2016.

#### PART I

#### Speyside

- 2. This Part shall have effect in Speyside from midday on Saturday Duration 16th April, 2016 to 1.00 a.m. on Sunday 17th April, 2016.
  - 3. Parking is prohibited on—

Parking

- (a) Windward Road, between the Speyside Public Cemetery prohibited and the Speyside Community Centre; and
- (b) Lucy Vale Road, to the Bridge.
- 4. A motorist may park on—

Parking permitted

- (a) Lucy Vale Recreation Ground;
- (b) the northern side of Lucy Vale Road from the Bridge, westward;
- (c) the northern side of Windward Road, between King's Bay Waterfall and the Speyside Public Cemetery;
- (d) the northern side of Windward Road from the Speyside Community Centre, eastward; and
- (e) the Speyside High School outer car park.

#### PART II

## SCARBOROUGH

5. This Part shall have effect in Scarborough from 2.00 p.m. on Duration Wednesday 20th April, 2016 to 1.00 a.m. on Thursday 21st April, 2016.

Parking prohibited

6. Parking is prohibited on Milford Road, between Wilson Road and Orange Hill Road.

Parking permitted

- 7. A motorist may park in—
  - (a) Garden Side Street car park;
  - (b) Market Square car park;
  - (c) Tambrin Square car park; and
  - (d) Republic Bank car park.

#### PART III

## Castara

Duration

8. This Part shall have effect in Castara from 11.00 a.m. to midnight on Thursday 21st April, 2016.

Parking prohibited

9. Parking is prohibited on Northside Road, between Sundeck Guest House and Spring Junction.

Parking permitted

10. A motorist may park on the Castara Playing Field.

## PART IV

## Mt. Irvine

Duration

- 11. This Part shall have effect in Mt. Irvine—
  - (a) from 9.00 a.m. to 8.00 p.m. on Saturday 23rd April, 2016; and
  - (b) from 9.00 a.m. to 8.00 p.m. on Sunday 24th April, 2016.

Parking permitted

12. A motorist may park on the southern side of Grafton Road, from the junction of Grafton Road and Buccoo Road (Buccoo four roads) to Pleasant Prospect.

#### PART V

## CROWN POINT

Duration

- 13. This Part shall have effect in Crown Point, as follows:
  - (a) from 11.00 a.m. on Friday 22nd April, 2016 to 1.00 a.m. on Saturday 23rd April, 2016;
  - (b) from 11.00 a.m. on Saturday 23rd April, 2016 to 1.00 a.m. on Sunday 24th April, 2016; and
  - (c) from 11.00 a.m. on Sunday 24th April, 2016 to 1.00 a.m. on Monday 25th April, 2016.

## 14. Parking is prohibited on—

Parking prohibited

- (a) Milford Road, Canaan, between Guy Street Extension (Azards' Tyre Shop) and ANR Robinson International Airport;
- (b) Kilgwyn Bay Road Extension (Stumpys' Bypass) from the junction of Kilgwyn Bay Road Extension (Stumpys' Bypass) and Milford Road, Canaan, to Store Bay Local Road;
- (c) Store Bay Local Road;
- (d) Milford Road By-Pass; and
- (e) Pigeon Point Road.

## 15. A motorist may park—

Parking permitted

- (a) in Store Bay Heritage Park;
- (b) in Store Bay Beach Facilities car park; and
- (c) on Bon Accord Recreation Ground.

16. A motorist proceeding west along Milford Road, Canaan, shall Traffic proceed in a southerly direction along Kilgwyn Bay Road Extension diverted (Stumpys' Bypass) from the junction of Kilgwyn Bay Road (Stumpys' Bypass) and Milford Road, Canaan, then turn west onto Store Bay Local Road, east onto Milford Road By-Pass, then east onto Milford Road, Canaan, and proceed in an easterly direction to the junction of Milford Road, Canaan and Kilgwyn Bay Road Extension (Stumpys' Bypass).

# 17. A motorist shall not proceed—

Traffic prohibited

- (a) west along Milford Road, Canaan, between the junction of Milford Road, Canaan and Kilgwyn Bay Road Extension (Stumpys' Bypass) and the junction of Milford Road By-Pass and Store Bay Local Road; and
- (b) east along Store Bay Local Road from the junction of Milford Road By-Pass and Store Bay Local Road, Crown Point, to the junction of Kilgwyn Bay Road Extension (Stumpys' Bypass) and Milford Road, Canaan.
- 18. A person driving a vehicle shall not be allowed access to Pigeon Conditional Point Road unless a pass granting access to that road, in respect of that access vehicle, has been issued by the Division of Tourism and Transportation of the Tobago House of Assembly.

# PART VI

## GENERAL

Removal and vehicles unlawfully parked

19. Without prejudice to any other liability incurred by the impounding of commission of a summary offence, vehicles found parked in contravention of this Order may be removed by a member of the Police Service and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
