ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER,
2016

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Point Fortin Borough Day Celebrations) Order, 2016.

2. This Order shall have effect from 6.00 p.m. on Friday 6th May, Duration 2016 to 6.00 a.m. on Sunday 8th May, 2016.

3. A person driving a motor vehicle shall not park on—

Parking
prohibited

- (a) Bryce Road;
- (b) Reid Road;
- (c) Atlantic Avenue;
- (d) Main Field Road;
- (e) Morris Road;
- (f) Church Road;
- (g) Montano Street;
- (h) Alleyne Street;
- (i) School Road;
- (j) Point Fortin Main Road, between Techier Main Road and Refinery Road;
- (k) Techier Main Road, between Handel Street and First Street;
- (l) Second Street, between First Street and Eastern Avenue;
- (m) Eastern Avenue, between Second Street and Point Fortin Main Road;
- (n) Warden Road, between Guapo-Cap-de-Ville Road and Southern Main Road; and
- (o) the emergency route prescribed under clause 7.

4. A person driving a motor vehicle is prohibited from driving on—

Vehicular
traffic
prohibited

- (a) Guapo-Cap-de-Ville Road, between Bryce Road and Richardson Street;
- (b) Wickham Street, between Bryce Road and Point Fortin Main Road;

- (c) Point Fortin Main Road, between Reid Road and Wickham Street;
- (d) Techier Main Road, between Handel Street and Frisco Roundabout; and
- (e) Bryce Road, between Wickham Street and Guapo-Cap-de-Ville Road.
- One-way traffic 5. A person driving a motor vehicle shall proceed along—
- (a) Montano Street, between Bryce Road and Reid Road, in a southerly direction only;
- (b) Bryce Road, between Montano Street and Point Fortin Main Road, in an easterly direction only;
- (c) Point Ligoure Road, between Point Fortin Main Road and Guapo-Cap-de-Ville Road, in a northerly direction only; and
- (d) Reid Road, between Point Fortin Main Road and Montano Street, in a westerly direction only.
- Traffic routes 6. (1) A person driving a motor vehicle and entering Point Fortin from Southern Main Road shall proceed in—
- (a) a westerly direction along Reid Road; or
- (b) an easterly direction onto Techier Road, then continue in an easterly direction along Techier Road, then in a northerly direction onto Canaan Road, then an easterly direction onto Richardson Street and then in a northeasterly direction onto Volunteer Road.
- (2) A person driving a motor vehicle and leaving Point Fortin via Guapo-Cap-de-Ville Road shall turn in an easterly direction onto Reid Road and then in a southeasterly direction onto Point Fortin Main Road.
- (3) A person driving a motor vehicle and proceeding to San Fernando shall exit—
- (a) Techier Main Road by proceeding in an easterly direction onto Second Street, then in a southerly direction onto Eastern Avenue, and then in an easterly direction onto Southern Main Road.
- (b) Guapo-Cap-de-Ville Road by proceeding in an easterly direction onto Reid Road and then in a southerly direction onto Southern Main Road;
- (c) Guapo-Cap-de-Ville Road by proceeding in a southerly direction onto Warden Road, then in a southwesterly direction onto Pilgrim Street, then in a southeasterly direction onto High Street and then in a northeasterly direction onto South Central Main Road; and

(d) Atlantic Avenue, by proceeding—

- (i) in an easterly direction onto Reid Road and then in a southerly direction onto Southern Main Road; or
- (ii) in a southwesterly direction onto Guapo-Cap-de-Ville Road, then in a southerly direction onto Warden Road, then in a southwesterly direction onto Pilgrim Street, then in a southeasterly direction onto High Street and then in a northeasterly direction onto the South Central Main Road.

7. A person driving a motor vehicle who has an emergency, shall ^{Emergency route} proceed in a northerly direction from Atlantic Avenue, then in an easterly direction onto Refinery Road, then in a northerly direction onto Guapo-Cap-de-Ville Road, then in an easterly direction onto Clifton Hill Road, then in a southerly direction onto Volunteer Road, then continue in a southerly direction onto Canaan Road, then in a southeasterly direction onto Techier Main Road, then continue in a southeasterly direction onto Second Street, then in a southerly direction onto Eastern Avenue, and then in an easterly direction onto Point Fortin Main Road towards San Fernando.

8. (1) The San Fernando taxi stand will be relocated to the lay-by ^{Taxi stands} on the eastern side of Point Fortin Main Road, approximately five hundred metres north of Frisco Roundabout.

(2) The Cedros and Erin taxi stands will be relocated to the car park of the Point Fortin Catholic Church on the eastern side of the Guapo-Cap-de-Ville Road in the vicinity of the Guapo-Cap-de-Ville Road and Reid Road intersection.

9. Without prejudice to any other liability incurred by the ^{Removal and impounding of vehicles unlawfully parked} commission of a summary offence, vehicles found parked in contravention of this Order may be removed by a member of the Police Service and impounded and dealt with in accordance with ^{parked} section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
