NOTICE is hereby given pursuant to Sections 18 and 28 of the Environmental Management Act, (the Act), the Environmental Management Authority ("the Authority"), upon the direction of the Minister of Planning and the Environment, hereby submits the Draft Revised National Environmental Policy (NEP). This project is deemed necessary given the vast changes to the environmental, development, economic and social paradigm of Trinidad and Tobago since the revision of the NEP in 2006.

And take notice that the comments of the public are hereby invited on the *Draft Revised National Environmental Policy*.
