INDEX OF RETAIL PRICES—August, 2017 (Base: January, 2015 = 100)

THE following Memorandum on the Index of Retail Prices is published for general information.

GENERAL INDEX

The All Items Index of Retail Prices calculated from the prices collected for the month of August, 2017, was 106.3, representing an increase of 0.2 point or 0.2% above the the All Items Index for July, 2017.

The Rate of Inflation, as measured by the percentage change in the average All Items Index for the period January to August, 2017, over the period January to August, 2016, was 2.1%. This rate is less than that observed for the period January to August, 2016, over the period January to August, 2015, which was 3.2%.

SECTION INDICES

FOOD AND NON-ALCOHOLIC BEVERAGES

The Index for Food and Non-Alcoholic Beverages increased from 112.3 in July, 2017, to 113.3 in August, 2017, reflecting an increase of 0.9%. Contributing significantly to this increase was the general upward movement in the prices of tomatoes, chive, celery, other chilled or frozen chicken (parts), hot peppers, table margarine, white flour, mixed fresh seasoning, oranges and pimento. However, the full impact of these price increases was offset by the general decrease in the prices of fresh whole chickens, garlic, cucumber, parboiled rice, bodi, soya bean oil, macaroni, fresh shark, other kinds of cheese (not cheddar), and carrots.

Price changes in this section for the month of August, 2017, accounted for a net overall increase of 0.2 point in the All Items Index.

OTHER SECTIONS

A further review of the data for August, 2017, compared with July, 2017, reflected an increase in the sub-index for Health of 0.1%. However, a decrease was noted in the sub-indices for Alcoholic Beverages and Tobacco of 0.1%, and Clothing and Footwear of 0.1%. All other sections remained unchanged.

Price changes in the Other Sections for the month of August, 2017, had a negligible effect on the All Items Index.
