APPOINTMENT OF A PRIVATE WAREHOUSE (Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Glen Singh, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the places specified in Schedule A and B hereto to be Private Warehouses for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by Messrs. Du Buy Duty Free Limited, of Piarco International Airport, Piarco, South Terminal, *viz:* Perfumes, cosmetics, liquors, watches, jewellery leather goods, sunglasses, bags, confectionary, cigars, cigarettes, electronics, clothing, toys and such other goods as I may subsequently approve.

SCHEDULE A

An enclosed area measuring 3 metres by 6.193 metres, comprising a total of 18.58 square metres, on the south terminal of the Piarco International Airport. The building is a concrete structure with a galvanized roof and access is gained by a metal door on the northern side.

The area is bounded to the east by Bond BW-001, to the west by a driveway, to the north by a walkway and to the south by Bond BW-005.

Schedule B

An enclosed area measuring 8.5 metres by 4 metres and 2.2 metres by 6.87 metres, comprising a total of 49.11 square metres, on the south terminal of the Piarco International Airport. The building is a concrete structure with a galvanized roof.

The area is bounded to the east by the main terminal building, to the west by a concrete walkway, to the north by an open area and to the south by Stechers Perfume Bond.
