THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(TOBAGO NATIONAL DAY OF REMEMBRANCE) ORDER,  
2017

1. This Order may be cited as the Traffic Restriction (Temporary Citation  
Provisions) (Tobago National Day of Remembrance) Order, 2017.

2. This Order has effect from 6.00 a.m. to 1.00 p.m. on Sunday Duration  
12th November, 2017.

3. Parking is prohibited on—

prohibited

- (a) Jerningham Street;
- (b) Ross Street;
- (c) Piggot Street, from the junction of Burnett Street to Bacolet Connector Road;
- (d) Bacolet Connector Road, from the junction of Piggot Street to the junction of Main and Bacolet Streets;
- (e) Main Street, from the junction of Main and Bacolet Streets to the junction of Main and Burnett Streets;
- (f) Burnett Street;
- (g) Old Market Car Park and Piggot Street;
- (h) Bacolet Street, from the junction of Main and Bacolet Streets to Hay and Young Streets; and
- (i) Old Market Car Park, Piggot Street.

4. Vehicular traffic is prohibited on—

- (a) Jerningham Street;
- (b) Ross Street;
- (c) Piggot Street, from the junction of Burnett Street to Bacolet Connector Road;
- (d) Bacolet Connector Road, from the junction of Piggot Street to the junction of Main and Bacolet Streets;

- (e) Main Street, from the junction of Main and Bacolet Streets to the junction of Main and Burnett Streets;
- (f) Burnett Street; and
- (g) Bacolet Street, from corner Main and Bacolet Streets to Hay and Young Streets.

Parking permitted

5. Parking is permitted for the duration of this Order at—

- (a) Republic Bank Car Park, Burnett Street for specially invited guests; and
- (b) Gardenside Street Car Park for the public.

Removal and impounding of vehicles unlawfully parked

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
