NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON AN APPLICATION FOR A CERTIFICATE OF ENVIRONMENTAL CLEARANCE WHICH REQUIRES AN ENVIRONMENTAL IMPACT ASSESSMENT SUBMITTED BY CSA OCEAN SCIENCES INC., TRINIDAD AND TOBAGO BRANCH ON BEHALF OF BHP BILLITON (TRINIDAD-2C) LIMITED AND BHP BILLITON (TRINIDAD-3A) LIMITED

NOTICE is hereby given that BHP Billiton (Trinidad-2C) Limited and BHP Billiton (Trinidad-3A) Limited (BHP) are desirous of drilling and completing up to ten (10) wells for the production and re-injection of oil and gas including the conduct of vertical seismic profiles and installation of subsea infrastructure within Blocks 2(c) and 3(a), located offshore the North East Coast of Trinidad. This project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order thus requiring a Certificate of Environmental Clearance pursuant to **Section 35 of the Environmental Management Act, Chapter 35:05 ("the Act")**. BHP has applied for a Certificate of Environmental Clearance ("the Certificate") from the Environmental Management Authority ("the Authority") for this project.

And take notice that the comments of the public are hereby invited on the application for the drilling and completion of up to ten (10) wells for the production and re-injection of oil and gas including the conduct of vertical seismic profiles and installation of subsea infrastructure within Blocks 2(c) and 3(a), located offshore the North East Coast of Trinidad, which requires an Environmental Impact Assessment.

And take notice that the Authority has, for the purposes of the Certificate and pursuant to **Section 28(1)(b)** of the Act, established an Administrative Record that includes a written description of the proposed action, the major environmental issues involved in the matter under consideration, copies of relevant documents or other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and of the Authority's reasons for the proposed action.
