THE Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) for the Health Services Support Program (HSSP) and intends to apply part of the proceeds for an individual Consultant to undertake Biomedical Engineering services within the Trinidad and Tobago Health Sector.

The consulting services ("the Services") include the provision of technical expertise during the implementation of HSSP project activities for:

1. Management and maintenance of clinical equipment;
2. Updating the Biomedical Engineering Standard Procedures Manual;
3. Identification of clinical equipment requirements and preparation of technical specifications for procuring the items;
4. Supporting the procurement process for clinical equipment;
5. Training of clinical staff;
