A pre-tender meeting followed by a site visit will be held for prospective tenderers at 10.00 a.m. on Friday 2nd February, 2018, at Level 20, LA LUNE Conference Room, Eric Williams Finance Building, Independence Square, Point-of Spain.

Tenders must be accompanied by the following:

- (a) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender;
- (b) a valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original and five (5) copies of the Tender should be placed in sealed envelopes and clearly marked on the outside: "Tender for Provision of Services for the Operation and Maintenance of Mechanical, Electrical and Plumbing Systems at the Eric Williams Finance Building, Ministry of Finance, for a period of three (3) years".
