APPOINTMENT OF A PRIVATE WAREHOUSE  
(*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kathy Ann Yearwood Matthews, Acting Comptroller of Customs and Excise, acting under the provisions of Section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereunder to be a Private Warehouse for the storage of machinery, equipment, raw materials and semi-manufactured goods imported or taken out of bond by Domus Windows and Doors Limited for the manufacture of plastic, plastic products, alumina, aluminum and aluminum products or other goods as may subsequently be approved.
