NOTICE is hereby given that the Environmental Management Authority (EMA) has undertaken the Designation of the Scarlet Ibis as an Environmentally Sensitive Species (ESS), pursuant to Section 41 of the Environmental Management (EM) Act, Chap. 35:05 which provides that the EMA may designate any species of living plant or animal as an "environmentally sensitive species", requiring special protection to achieve the objects of the EM Act.

And take notice that the comments of the public are hereby invited on the Draft Legal Notice for the Designation of the Scarlet Ibis as an ESS.
