COMMENCEMENT OF ELECTORAL REGISTRATION FOR LOCAL GOVERNMENT BYE- ELECTION, 2018 IN THE ELECTORAL DISTRICTS OF BARATARIA AND BELMONT EAST

Members of the public including persons already registered, are hereby notified that under Section 30 of the Representation of the People Act Chap. 2:01, Her Excellency, the President of the Republic of Trinidad and Tobago has issued a Proclamation fixing **Friday 8th June, 2018** as the date for the Commencement of an Electoral Registration for the Local Government Bye – Election in the two (2) Electoral Districts of Barataria and Belmont East in Trinidad.

In accordance with the said Section 30 the Electoral Registration will be conducted in the various Registration Area Offices [listed hereunder] up to and including Sunday 17th June, 2018.

Please Note: The above electoral registration period excludes the public holiday on Friday, 15th June, 2018 (Eid Ul-Fitr).

The purpose of the exercise is to facilitate those persons who:

- (1) have attained the age of 18 years and over, but who have not been registered as electors;
- (2) have been registered as electors but have changed their addresses and have not yet notified the Registration Officer of such change of address;

- (3) have been registered as electors and have changed their names because of marriage or otherwise, but their previous names appear on the Preliminary List of Electors;
- (4) have been registered as electors but their names do not appear on the Preliminary List of Electors.

During the period of the Electoral Registration, business will be conducted at the Registration Area Offices as follows:

Monday to Friday 8:00 a.m. to 6:00 p.m.
 Saturday 9:00 a.m. to 3:00 p.m.
 Sunday 9:00 a.m. to 2:00 p.m.

It is important to note that at the close of business on Sunday 17th June, 2018, no further registration or registration related matters will be effected.
