DRAFT NAVIGATIONAL AIDS REGULATION OF THE SHIPPING ACT

The following Draft Amendment to the Navigational Aids Regulation of the Shipping Act is submitted for public Comment

DRAFT THE SHIPPING (NAVIGATIONAL AIDS) (AMENDMENT) REGULATIONS 2017

Citation

1. These Regulations may be cited as the Shipping (Navigation Aids) (Amendment) Regulations, 2017.

Amendment

- 2. The Shipping (Navigational Aids) (No.2) Regulations, 1989 are amended as follows:
 - (a) in paragraph 3 of Part II of the Schedule by the addition of the following sub-paragraphs-
 - '3A Notwithstanding paragraph 2 an additional payment shall be levied on foreign ships at the rate of \$0.13 per ton per voyage or stay within Trinidad and Tobago waters exceeding fourteen days.
 - 3B (1) The following foreign ships shall be exempt from the provisions of paragraph 3A:
 - (a) ships operating within Trinidad and Tobago waters under a certificate of drogher;
 - (b) ships undergoing work at a dry docking or repair facility within Trinidad and Tobago waters;
 - (c) ships within Trinidad and Tobago waters awaiting access to dry docking or repair facilities for a period not exceeding thirty days after the expiration of the initial fourteen day period; and
 - (d) pleasure craft;
 - (2) Foreign ships engaged in maintenance provided by a local company while anchored at sea shall be exempted from the payment of fees as provided under paragraph 3A for a period not exceeding sixty days after the expiration of the initial fourteen day period.'
 - (b) in Part III of the Schedule by the addition of the following paragraph:
 - '6. The payment referred to in paragraph 3A of Part II shall be paid on or before the second working day of each week that the vessel is in Trinidad and Tobago waters.'
