LIST OF REGISTRANTS AS AT 31ST MARCH 2018

The Trinidad and Tobago Securities and Exchange Commission ("the Commission") is responsible for ensuring that the securities industry operates in a fair, transparent and efficient manner in order to protect the rights of investors.

The Commission regulates the securities market by registering all securities that are distributed to the public, all issuers of those securities, and market intermediaries directly involved in the issuance, offering and sale of those securities e.g. *Broker-Dealers, Investment Advisers, Underwriters, and Self-Regulatory Organizations*. Certain employees or officers of Broker-Dealers, Investment Advisers and Underwriters are also required to be registered with the Commission as Registered Representatives.

HOW DOES REGISTERING WITH THE COMMISSION PROTECT INVESTORS?

Registration requires all registrants (issuers of securities as well as market intermediaries such as *Broker-Dealers, Investment Advisers, and Underwriters*) to provide the Commission with pertinent information regarding the registrant itself (such as background information on its operations, management and financial position) as well as the securities being distributed. The Commission ensures that the information meets the requirements of the law and is available to the public.

Firms and individuals are registered by category - each registration category attracts different educational, experience, and financial requirements, and permits different activities. The Commission ensures that the companies are genuine entities with a registered office, staffed by qualified professionals who possess the knowledge, skills and experience to conduct the class of business for which the companies are being registered.

WHAT ARE THE QUALIFICATIONS FOR REGISTRATION?

Registration will not be granted unless the Commission is satisfied that an applicant is fit and proper, meets the requirement of the law with respect to capital and educational qualifications, and discloses any information that may affect the conduct and integrity of his/her business. This information is also available for public viewing at the Commission.

However, the provision of information does not end after the initial registration. Registrants are required to continuously provide the Commission, as well as investors, with information inclusive of changes which may positively or negatively impact the performance of their business and the securities available to investors.

IS REGISTRATION AN ENDORSEMENT?

While we advise investors to deal only with registrants that are registered with the Commission, registration with the Commission is NOT an endorsement of the registrant or of any security. The Commission provides neither guarantee nor opinion on the performance of a registrant or security.

Always remember, even though you are dealing with someone who is registered with the Commission, you should evaluate the registrant and the securities being offered and if necessary, seek independent financial advice before making an investment decision.

DEFINITION OF TERMS

• Broker-Dealer

A firm acting as an intermediary between a buyer and a seller of securities, usually for a fee or a commission. When acting as a broker, a Broker-Dealer executes orders on behalf of his/her client. When acting as a dealer, a Broker-Dealer executes trades for his/her firm's own account

Investment Adviser

An individual or firm that advises clients on investment in, or the purchase or sale of securities on a professional basis.

• Registered Representative

An employee or officer of a registered Broker-Dealer, Investment Adviser or Underwriter who liaises with members of the public on behalf of their employers further to the offering, distribution or sale of securities.

• Reporting Issuer

A corporation that has issued or proposes to distribute securities to the public and is subject to the continuous disclosure requirements of the Commission.

Self-Regulatory Organization

A non-governmental organization that has the power to create and enforce industry regulations and standards. The priority is to protect investors through the establishment of rules that promote ethics and equality.

• Sponsored Broker-Dealer

An individual who is employed by a Brokerage firm from a foreign jurisdiction. This individual aligns himself/herself with a local Broker-Dealer who sponsors his/her registration with the Commission. A Sponsored Broker-Dealer that is registered with the Commission can conduct securities business in Trinidad and Tobago for a maximum of 90 days in a calendar year.

Underwriter

A company that arranges for the issuance or distribution of securities and/or agrees to purchase any unsold securities thereby guaranteeing full subscription.

In accordance with the requirements of Section 52(8) of the Securities Act, 2012, the Commission has provided a listing of its Broker-Dealers, Investment Advisers, Underwriters, Self-Regulatory Organizations and Reporting Issuers as at March 31st, 2018 as indicated on the following pages.

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, 1999 (FOIA) the Ministry of Housing and Urban Development is required by law to publish the following statement, which lists the documents and information generally available to the public.

- A legal right for each person to access information held by the Ministry of Housing and Urban Development.
- (2) A legal right for each person to have official information relating to him/her amended where it is incomplete, incorrect or misleading.

Section 7 (1) (a) (i)

Mission and Vision Statements

The Mission and Vision Statements for the Ministry of Housing and Urban Development have not been developed to date, since the Ministry has been recently established.

Function

The housing portfolio of the Ministry of Housing and Urban Development involves the provision of appropriate housing solutions for low and middle income families through the direct construction and distribution of new homes, the development of appropriate home financing mechanisms and development of sustainable communities. Further, until 23rd September, 2015, the housing portfolio of the Ministry included the provision of developed housing lots to VSEP-availed ex-workers of Caroni (1975) Ltd.

The Ministry has also placed emphasis on the maintenance of housing stock, the upgrading of infrastructure in Government housing developments and the distribution of grants and subsidies to members of the public through the requisite divisions for the purpose of improving the social conditions of poor families, enhancing the aesthetic quality of Government developments and reducing the annual national demand for new homes.

ORGANIZATIONAL STRUCTURE AND STAFFING

The Ministry of Housing and Urban Development is headed by the Permanent Secretary and has one hundred and four (104) established and approximately seventy-five (75) contract positions in sum, comprising of clerical, technical/professional, secretarial, administrative and manipulative staff. The core Ministry is divided into the following Divisions/Sections/Units; as outlined in the organizational chart attached.

Organizational Chart

Human Resource Service Division

This division is responsible for the management of the Ministry's human capital in an effective, fair, and consistent manner, so as to achieve the Ministry's strategic goals and objectives. The

functions include recruitment, human resource planning, training and development, performance evaluation management, development of human resource management policies, industrial and employee relations and compensation.

General Administration/Operations

This section is responsible for the provision of support services for the Ministry, through the registry and office management functions. The Registry ensures the orderly recording and safe storage of Ministry files and documents. The office management section is responsible for the procurement of goods and services, e.g. office supplies, furniture, equipment, messenger, maid, janitorial services etc.

Economic Research and Planning Unit

The Economic Research and Planning Unit is responsible for assisting in the preparation of policies, programmes and projects in the housing sector and ensuring that these policies, programmes and projects are executed in accordance with Government's mandate.

This Unit is instrumental in monitoring the budgetary requirements of the divisions and agencies under the purview of the Ministry of Housing and Urban Development. Some of the areas which the Economic Research and Planning Unit places emphasis on are as follows:

- Oversight of the implementation of the Public Service Investment Programme (PSIP);
- Preparation of annual budgets (mainly capital);
- Monitoring of the Ministry's performance under Government's Policy Framework for Sustainable Development;
- Provide data and advice on ongoing projects to the Minister/ Permanent Secretary;
- Providing comments on reports and documents (in-house or from other Ministries/agencies);
- Develop initiatives to ensure that goals are achieved including liaising with other departments within the Ministry;
- Ensure internationally agreed goals are achieved e.g. The Millennium Development Goals(MDGs);
- Disbursement of Emergency Shelter Relief Grants;

- Functioning on Committees; and
- Preparation of comprehensive reports on the Ministry (e.g. Action Plan report, Administrative reports).

Finance and Accounts Unit

The functions of the Accounts unit include:

- The processing of the Ministry's payroll;
- Processing payments to all the suppliers of goods and services to the Ministry;
- Processing payments to the Ministry's Agencies for their operational and capital projects;
 and
- Preparing statutory and other reports for the Ministry of Finance, the Comptroller of Accounts and the Auditor General.

Information Technology (IT) Services Unit

The IT Unit is responsible for the Ministry's IT platform which allows the Ministry and its support agencies to share information in real-time, and so improves the public's access to housing information through the internet interface. The four (4) broad areas of services provided by the IT Unit are:

- Systems analysis: i.e. analyzing the business needs of the Ministry and its agencies to identify business problems, and recommend possible solutions;
- Systems development: i.e. the development and maintenance of new applications;
- Systems installation: i.e. installation, maintenance and monitoring of the Ministry's computer network, inclusive of the hardware and software; and
- Systems administration: i.e. implementation, training and documentation of new systems and applications.

People Issues Resolution Co-ordinating Unit

The People Issues Resolution Co-ordinating Unit was established through a mandate from the office of the Prime Minister in the year 2010. The core functions and services of this Unit are:

 To investigate and facilitate the resolution of the time sensitive issues of clients under the purview of the Ministry of Housing and Urban Development;

- To provide a high level of quality customer service to all clients;
- To maintain a database of client information for monthly and quarterly reporting;
- To refer clients to relevant Divisions within the Ministry in order to address their first time issues;
- · To provide information on government services; and
- To take clients' suggestions and recommendations on how government services can be improved

Housing Policy Facilitation and Implementation Unit (HPFIU)

The Housing Policy Facilitation and Implementation Unit administers the Home Improvement Grant Programme which targets low income persons with a total maximum household income of \$5,000 per month. The maximum amount of the Grant is \$15,000, and the funds are used to carry out repairs to the beneficiaries' homes. Beneficiaries are selected through a random draw system.

Programme Monitoring and Coordinating Unit (PMCU)

The Programme Monitoring and Coordinating Unit (PMCU) has the responsibility of monitoring and implementing the Inter American Development Bank (IDB) Assisted Neighbourhood Upgrading Programme, through the following Subsidies:

- The Home Construction Subsidy this is a subsidy of up to \$50,000.00 to assist families in the <u>construction</u> of a new housing solution. In order for an Applicant to qualify for this subsidy, the Applicant's total household income must not exceed the sum of \$84,000.00;
- The Home Purchase Subsidy this is a subsidy of up to \$50,000.00 granted to assist families in the <u>purchase</u> of new housing solutions. In order for an Applicant to qualify for this subsidy, the Applicant's total household income must not exceed the sum of \$84,000.00; and
- The Home Improvement Subsidy this is a subsidy of up to \$20,000.00 to assist families with needed home improvement up to a maximum of \$20,000.00.

Corporate Communications Unit

The Corporate Communications Unit plays a key role in facilitating various platforms to encourage greater engagement of and, participatory involvement of all of the Ministry's stakeholders, so that there is greater support for the work carried out by the Ministry. The Unit also adopts a proactive approach to the dissemination of information so that all stakeholders are aware of the activities of the Ministry while ensuring that the information delivered is accurate, reliable, timely, relevant and accessible to the various publics served by the Ministry of Housing and Urban Development.

Legal Services Unit

The Legal Services Unit provides legal opinions, oversight and guidance to the Ministry and its agencies on various matters that pertain to their operations within a legal framework. The Unit ensures that the Ministry adheres to sound legal principles in executing its functions and ensures that the Ministry fulfills all statutory obligations. The Unit facilitates the advancement of the Ministry and its agencies' legislative agenda as well as the examination of policy from a legal standpoint in relation to housing and urban development. Officers of the Unit function as Instructing Attorneys to the Solicitor General and Chief State Solicitor Departments for all litigious matters in which the Ministry is involved.

Internal Audit

The Internal Audit Unit is responsible for ensuring that the government's accounting system as prescribed by the Ministry of Finance is implemented in the Ministry, which involves ensuring that all the Ministry's accounting records are complete, accurate and appropriately secured.

Library Services

The Library provides staff of the Ministry with traditional library services, research facilities, edocument delivery and information consultation services.

The Trinidad & Tobago Housing Development Corporation (HDC)

The Trinidad and Tobago Housing Development Corporation (HDC), is an Agency of the Ministry of Housing and Urban Development, and was established by Act No. 24 of 2005. The HDC is managed by a Board of Directors. The functions of the HDC include the following:

- Provision of quality, affordable housing solutions for first-time home-owners who fall
 within the low to middle income brackets and associated community facilities for use by
 these families;
- Carry out the broad policy of the Government in relation to housing;

Land Settlement Agency

RESPONDING TO A REQUEST FOR ACCESS TO INFORMATION

Retrieving Documents

The Ministry of Housing and Urban Development is only required to furnish copies of documents currently in its possession or when the said documents could be retrieved from storage. Prior to the commencement of the FOIA, old records may have been destroyed. The granting of a request for such documents may therefore be impossible. Various laws, regulations and manuals state the time periods for keeping records before they may be destroyed.

Furnishing Documents

An applicant is entitled to copies of information that the Ministry of Housing and Urban Development (MHUD) has in its possession, custody or power. The MHUD is required to furnish one copy of a document to an applicant. If a legible copy of a document cannot be made for release, the MHUD may not attempt to reconstruct it. Instead, the best copy available will be furnished and a statement regarding its quality made in the response to the applicant.

Please note that the Ministry of Housing and Urban Development is not compelled to do the following:

- 1. Create new documents. The MHUD is, for example, not required to write a new program to enable a computer to print information in the format preferred by the applicant.
- 2. Perform research for the applicant.

Time Limits

- General The FOIA establishes time limits for the Ministry to make a decision regarding its ability to disclose the documents requested. If these deadlines are not met, the FOIA gives the applicant the right to proceed as if his\her request has been denied. The MHUD will diligently try to comply with the time limits, but if it appears that processing the request may take longer than the statutory limit, the request will be acknowledged and the applicant advised of its status. Since there is a possibility that requests may be misaddressed or misrouted, the applicant may wish to call or write to the Designated Officer to confirm that the MHUD received the request and to ascertain its status.
- Time Allowed The MHUD will determine whether to grant the request for access to
 information as soon as practicable but no later than 30 days as required by Section 15 of
 the FOIA. If a decision is taken to grant access to the information requested, the applicant
 will be permitted to inspect the documents or be provided with copies, if so requested.
- Fees and Refunds The Freedom of Information Fees and Charges Regulations prescribe the fees related to the search, retrieval and provision of documents. The applicant is entitled to receive the document/s within seven days of payment of the relevant fee. If the MHUD fails to provide the information within the seven day period he\she is entitled to a refund of the fees paid in addition to access to the document/s requested.



Sections 7, 8 and 9 of the Freedom of Information Act Chapter 22:02 (FOIA)

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act (FOIA), 1999, the Personnel Department is required to publish a statement setting out the particulars of the organisation and the functions of the Personnel Department indicating the decision making powers and other powers, and statements which list the documents and information generally available to the public.

The Freedom of Information Act, Chapter 22:02, gives members of the public:

- a legal right to access information held by the Personnel Department, limited by exceptions and exemptions as specified in the Act;
- a legal right to have official information relating to himself/herself amended where it is incomplete, incorrect or misleading;
- a legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA;
- a legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

Section 7 Statements

Section 7(1) (a) (i): Functions and structure of the Personnel Department

The Personnel Department, the Head of which is the Chief Personnel Officer (CPO), was established by the Civil Service Act, No. 29 of 1965, which came into effect on August 27, 1966. This Act, which is now Chapter 23:01 of the Laws of the Republic of Trinidad and Tobago, sets out, at Section 14(1), the duties and responsibilities of the Personnel Department. Section 14(1) states that:

- "14(1) The Department shall carry out such duties as are imposed on it by this Act and the Regulations, and in addition shall have the following duties:
 - a) to maintain the classification of the Civil Service and to keep under review the remuneration payable to civil servants;

PUBLIC STSTEMENT OF THE PERSONNEL DEPARTMENT - 2017 (FOIA)—CONTINUED

- b) to administer the general regulations respecting the Civil Service;
- c) to provide for and establish procedures for consultation and negotiation between the Personnel Department and an appropriate recognised association or associations in respect of:
 - (i) classification of offices;
 - (ii) any grievances;
 - (iii) remuneration; and
 - (iv) the terms and conditions of employment."

The Personnel Department is also empowered to perform similar functions under provisions found in the following Acts:

- The Education Act, Chap. 39:01;
- The Police Service Act, Chap. 15:01;
- The Fire Service Act, Chap. 35:50;
- The Prison Service Act, Chap. 13:02.

These Acts all provide for consultation and negotiation between the Personnel Department and appropriate recognised associations representing the public officers in the respective Services with regard to the same matters as are specified at section 14(1) of the Civil Service Act. These Acts also provide for the procedures to be followed where negotiations result in agreement or disagreement between the parties.

Under the Statutory Authorities Act, Chap. 24:01, the functions of the Personnel Department, as specified in the Service Acts mentioned above, are also the responsibility of the Personnel Department in relation to the organisations which fall under the Act so long as a personnel organisation has not been established by the President. However, where no agreement is reached after consultation and negotiation, the dispute is dealt with in accordance with the procedure relating to disputes as provided in the Industrial Relations Act (IRA), Chap. 88:01.

The CPO, by virtue of Section 2(4) (a) and Section 2(5) of the IRA, is deemed to be the Employer of any worker employed by the Government and of any worker employed by the Municipal Corporations respectively.

The clients of the Personnel Department include Ministries and Departments; regulatory bodies; public officers; officers of Statutory Authorities under the Statutory Authorities Act; workers, as defined by the IRA, who are in the employ of the Government or the Municipal Corporations; Associations and Unions representing government employees; and citizens.

Since its establishment in 1965, the core functions of the Personnel Department have revolved around matters pertaining to the determination of pay and other terms and conditions of employment and the administering of the general regulations governing the Public Service. However, its functions have undergone some evolution in keeping with changes in Government

policy. A major factor prompting change has been the initiative to establish a modern human resource management (HRM) system in the Public Service.

Currently, the Department's functions also include responsibility for:

- the provision of secretariat and technical services to the Salaries Review Commission (SRC)
 established by section 140 of the Constitution of the Republic of Trinidad and Tobago (a
 description is provided below);
- the provision of secretariat and technical services to the Human Resource Advisory Committee, which is a Sub-Committee of Cabinet with responsibility for monitoring salary and wage negotiations and remuneration arrangements of employees in the public sector (a description is provided below);
- administration of two (2) Group Health Plans, one for daily-rated employees and the other for monthly-paid officers in the Civil and Teaching Services and certain office holders within the purview of the SRC;
- advising on the pay and other terms and conditions of service of offices within the purview of the SRC; persons employed in those Statutory Boards and State Enterprises which receive guidelines from the Human Resource Advisory Committee; and members of the Defence Force;
- formulating policies in areas of Human Resource Management which are within its statutory mandate;
- formulating specific public sector policies in areas such as Occupational Safety and Health, the Public Service Employee Assistance Programme, and the development of guidelines for the Public Service on the treatment of persons afflicted with HIV/AIDS and other life threatening diseases;
- advising on and reviewing the legal and regulatory framework for aspects of Human Resource Management in the Public Service;
- providing advisory and consultative services to line agencies in respect of those matters which are within its purview;
- facilitating the implementation of specific strategic Human Resource Management initiatives in the Public Service;
- strengthening the capacity of Human Resource Management Units to implement those public-service-wide programmes and policies within the Department's purview;
- monitoring and auditing the implementation of those public-service-wide programmes and policies within the Department's purview; and
- determining the terms and conditions of employment of persons employed on contract in Cabinet approved positions in the Public Service and in Statutory Authorities.

The Salaries Review Commission (SRC)

The Salaries Review Commission (SRC), comprising a Chairman and four members who are appointed by the President of the Republic of Trinidad and Tobago, is required by section 141(1) of the Constitution, to review, with the approval of the President of the Republic of Trinidad and Tobago, the salaries and other conditions of service of the President, Members of Parliament and the holders of various prescribed offices, including Top Managers in the Public Service.

The Human Resource Advisory Committee (HRAC)

The Human Resource Advisory Committee is a Sub-Committee of Cabinet with responsibility for monitoring wage and salary negotiations in the public sector. The scope of the Committee includes the monitoring of negotiations/revision of pay and other terms and conditions of employment of Statutory Authorities/Boards and Corporations as well as companies that are wholly or majority owned by the State.

The Personnel Department's Vision and Mission Statements are as follows:

Vision: To be the model provider of contemporary human resource management and

industrial relations solutions in the public sector.

Mission: To excel in the development of quality human resource management policies,

systems and solutions and in the application of industrial relations best practices for

the well-being of the Public Service and the nation.

A Strategic Plan 2018-2020 is currently being developed to enable the Department to fulfilits legal and administrative responsibilities as well as to meet its challenges.

The Chief Personnel Officer is supported by two (2) Deputy Chief Personnel Officers. The Department comprises of seven (7) Divisions. They are:

- Compensation Management;
- Benefits Management;
- Industrial and Labour Relations;
- Human Resource Policy Planning and Research;
- Human Resource Management Services;
- Legal Services; and
- Corporate Services.
