THE GOVERNMENT of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) towards the cost of the Strengthened Information Management at the Registrar General's Department and intends to apply part of the proceeds to the engagement of an individual for the above mentioned Consultancy.

Background: The Registrar General's Department (RGD), Ministry of the Attorney General and Legal Affairs (MAGLA) is responsible for the registration, dissemination and preservation of real and personal property held in Trinidad and Tobago. The collection houses documents that are critical to ascertaining land tenure of all privately owned property in Trinidad and Tobago and relied on by local and foreign investors to provide information on land parcels.

In carrying out its objective of Strengthened Information Management, a formal evaluation of the existing paper and electronic based collection is required. This consultancy seeks to engage the services of a suitably qualified individual with a Master's degree from a recognized conservation training program and significant experience in training and treating with fragile, oversized and historically valuable objects to carry out the assessment and produce a report on the current state of the records, recommendations for remedial actions and an implementation plan with priorities and timelines. The overall objective of this consultancy is to assess the existing collection and make recommendations towards prolonging its existence against decay and destruction.

In this regard, the Central Tenders Board (CTB), on behalf of the Executing Agency, the Ministry of the Attorney General and Legal Affairs, invites eligible individuals to indicate their interest in providing the services by submitting their cover letter and curriculum vitae providing information demonstrating that they have the required qualifications and relevant experience in accordance with the Terms of Reference (TOR) and using the curriculum vitae format at Appendix II of the TOR.

Individuals will be selected in accordance with the procedures set out in the Inter-American Development Bank: Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank (GN-2350-9) and is open to all eligible individuals as defined in the policies which can be found at website: <http://www.iadb.org/procurement>.
