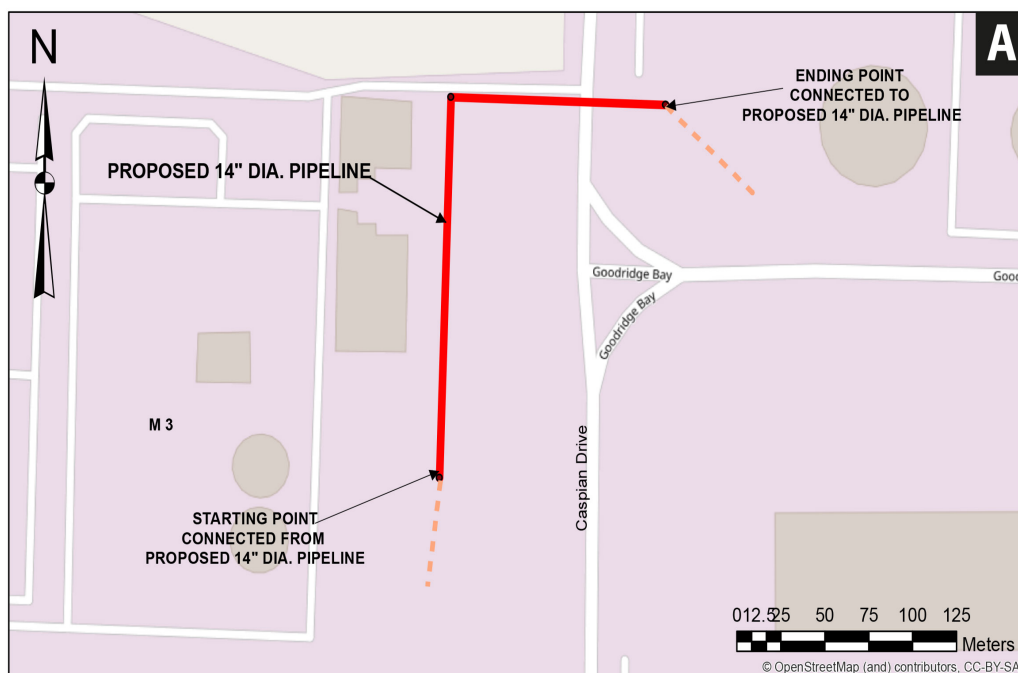
**SCHEDULE ABOVE REFERRED TO – DESCRIPTION OF PIPELINE**

<b>Description:</b>	The proposed 355.60 mm (14.00 in) diameter natural gas pipeline will run approximately 292 m (958 ft), from the M3 fence line to the western battery limit of the Methanol Complex Tank Farm, while crossing Caspian Drive. The road crossing will be done via Horizontal Directional Drilling (HDD). See Reference Map "A".
