REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE
MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)
(PORT-OF-SPAIN, DIEGO MARTIN AND ST. JAMES)
REGULATIONS, 2018

1. These Regulations may be cited as the Traffic Control Citation
(Experimental Scheme) (Port-of-Spain, Diego Martin and St. James)
Regulations, 2018.

2. These Regulations shall commence on Monday 3rd September, Duration
2018 and expire on Sunday 2nd December, 2018.

3. A person driving a motor vehicle shall proceed in a— One-way
traffic
(a) southerly direction only along George Street, between
the intersections of Independence Square North and
Independence Square South, Port-of-Spain; and
(b) westerly direction only along Panka Street, between the
intersections of Vidale Street and Ethel Street, St. James.

4. A person driving a motor vehicle shall not enter— No entry
(a) George Street Extension from Independence Square South,
Port-of-Spain;
(b) Panka Street from Ethel Street, St. James; and
(c) Aquamarine Drive from Onyx Drive, Diego Martin.

5. A person driving a motor vehicle shall proceed in a southerly One-way
traffic
direction only along Aquamarine Drive between the intersection of
Sardonyx Drive and Onyx Drive, Diego Martin, Monday to Friday,
during the hours of 7.00 a.m. to 9.00 a.m. and 2.00 p.m. to 4.00 p.m.

Offence and
penalty

6. A person who contravenes these Regulations is liable on summary conviction for a first offence, to a fine of seven hundred and fifty dollars and on any subsequent convictions, to a fine of one thousand dollars.

Removal and
impounding of
vehicles
unlawfully
parked

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
