THE PETROTRIN VESTING ACT, CHAP. 62:07

ORDER

MADE BY THE MINISTER OF FINANCE UNDER SECTION 6 OF  
THE PETROTRIN VESTING ACT

THE PETROTRIN VESTING ORDER, 2018

WHEREAS by virtue of the Petrotrin Vesting Act, Chap. 62:07 (hereinafter referred to as “the Act”) the assets, liabilities and obligations of Trinidad and Tobago Oil Company Limited (hereinafter referred to as “TRINTOC”) and Trinidad and Tobago Petroleum Company Limited (hereinafter referred to as “TRINTOPEC”) including those set out in the First Schedule subject to the exceptions set out in Second Schedule to the Act were transferred to and vested in Petroleum Company of Trinidad and Tobago Limited (hereinafter referred to as “PETROTRIN”) on the 1st October, 1993:

And whereas it is provided by section 6 of the Act that the Minister to whom responsibility for finance is assigned may, by Order, transfer to and vest in PETROTRIN the assets of TRINTOC and TRINTOPEC or any of those assets as set out in the Second Schedule to the Act:

And whereas it is expedient that the assets hereinafter mentioned be transferred to and vested in PETROTRIN:

Now, therefore, the Minister in pursuance of section 6 of the Act makes the following Order:
