ORDER

MADE BY THE MINISTER OF WORKS AND TRANSPORT UNDER SECTION 65
OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (CHAGUANAS/EDINBURGH 500/
ENDEAVOUR/ENTERPRISE/MONTROSE/ST. HELENA) ORDER,
2018

1. This Order may be cited as the Traffic Control (Chaguanas/ Citation
Edinburgh 500/Endeavour/Enterprise/Montrose/St. Helena) Order, 2018.

2. This Order shall come into operation on Monday 10th Commencement
December, 2018.

PART I

CHAGUANAS

3. A person driving a motor vehicle shall not park on— Parking prohibited
- (a) Xavier Street from 7.00 a.m. to 9.00 a.m., Monday to Friday except on public holidays;
 - (b) Southern Main Road between Factory Road and the Triangle in Chase Village;
 - (c) Factory Road between the Southern Main Road and Perseverance Road;
 - (d) Chaguanas Main Road; and
 - (e) Southern Main Road from its intersection with Chaguanas Main Road to its intersection with Caparo Valley Brasso Road.
4. A person driving a motor vehicle shall proceed in a— One way traffic
- (a) westerly and northerly direction on Parker Street from St. Yves Street to Rene Street;
 - (b) northerly direction only on Market Street, between Ramsaran Street and Eleanor Street;

- (c) easterly direction only on the Chaguanas Main Road between Railway Road No. 2 and Perseverance Road; and
(d) southerly direction only on Andrew Street between the Southern Main Road and Algernon Street.
- No entry to maxi taxis 5. A driver of a maxi taxi shall not enter Orchard Boulevard from Rudranath Capildeo Street between 6.00 a.m. and 6.00 p.m. from Monday to Saturday.
- Left turn only 6. A person driving a motor vehicle in a westerly direction along the Chaguanas Main Road must turn left onto Railway Road.
- No right turn 7. A person driving a motor vehicle shall not turn right from—
(a) the Caroni Savannah Road onto Chaguanas Main Road, at its intersection with the Chaguanas Main Road; and
(b) the Southern Main Road onto Andrew Street, at its intersection with Andrew Street.
- No parking, stopping or waiting 8. A person driving a goods vehicle shall not between the hours of 7.00 a.m. to 9.00 a.m. and 3.00 p.m. to 5.00 p.m. on Monday to Friday, except on public holidays park, stop or wait on—
(a) the Southern Main Road between Montrose Junction and Busy Corner; and
(b) the Chaguanas Main Road between Busy Corner and Marie Street.

PART II

EDINBURGH 500

- One way traffic 9. A person driving a motor vehicle shall proceed in an easterly direction only on St. Clair Street Extension between Edinburgh Boulevard and Onyx Circular.
- No right turn 10. A person driving a motor vehicle in a northerly direction shall not right turn Onyx Circular onto Clair Street Extension.
- No left turn 11. A person driving a motor in a northerly direction shall not turn left from Onyx Circular onto Clair Street Extension.
- No "U" turn 12. A person driving a motor vehicle proceeding south along Edinburgh Boulevard shall not make a "U" turn at the intersection of Edinburgh Boulevard and Kestrel Boulevard.

PART III

ENDEAVOUR

13. A person driving a motor vehicle shall not park on Rodney Road from its intersection with Endeavour Road and Eastern Avenue, Lange Park. Parking prohibited

14. A person driving a motor vehicle proceeding south along the Endeavour Connector Link Road shall not make a “U” Turn at its intersection with the Endeavour Connector Road. No “U” turn

PART IV

ENTERPRISE

15. A person driving a motor vehicle shall proceed in a— One way traffic
- (a) easterly direction only on Jackson Street, Enterprise Village, Chaguanas; and
 - (b) westerly direction only on Amow Street, Enterprise.

PART V

MONTROSE

16. A person driving a motor vehicle shall proceed in a northerly direction only on Galt Street. One way traffic

17. A person driving a motor vehicle in a northerly direction on Galt Street shall not turn left on St. John’s Road. No left turn

PART VI

ST. HELENA

18. A person driving a motor vehicle shall not park on— Parking prohibited
- (a) Caroni South Bank Road, between St. Helena Junction and Madras Road; and
 - (b) Golden Grove Road from Caroni South Bank Road to Caroni North Bank Road and Golden Grove Intersection.

19. A person driving a motor vehicle shall proceed in a southerly direction only on Mahepat Trace between Caroni South Bank Road and Gandhi Street. One way traffic

PART VII

GENERAL

Offence and
penalty

20. A person who contravenes this Order commits an offence and is liable on summary conviction to a fine of three thousand dollars or to imprisonment for three months.

Removal and
impounding
of vehicles
unlawfully
parked

21. Without prejudice to any liability incurred by the commission of a summary offence, vehicles found parking in contravention of this Order, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
