A PROCLAMATION

And whereas it is expedient that sections 1, 1A, 2, 3, 4, 5, 6, 7, 8(*a*), (*b*), (*c*), (*e*), (*g*), (*ga*), (*h*), (*i*), (*j*), (*k*) and (1), 9, 9A, 10(*a*), (*b*), (*c*), (*d*), (*e*), (*f*), (*g*), (*h*), (*i*), (*j*) except the new section 54A (2), (*k*), (*l*), (*m*), (*n*), (*o*), (*p*), (*q*), (*r*), (*s*), (*t*), (*u*) and (*v*), 11, 12, 13(*a*), (*b*), (*c*), (*ca*), (*d*), (*e*), (*f*) and (*g*) and 14 of the Act come into operation:

Now, therefore, I, **PAULA-MAE WEEKES**, President as aforesaid, do hereby fix—

(a) the 31st day of December, 2018 as the date on which sections 1, 1A, 2, 3, 4(a)(i), (ii) and (iii), (b), (c), (d) and (e), 5, 6, 7, 8(a), (b), (c), (e), (g), (ga), (h), (i), (j), (k) and (l), 9, 9A, 10(a), (b), (c), (d), (e), (f), (g), (h), (i), (j) except the new section 54A (2), (k), (l), (m), (n), (o), (p), (q), (r), (s), (t), (u) and (v), 11, 12, 13(a), (b), (ca), (e), (f) and (g) and 14 of the Act come into operation:

- (b) the 21st day of July, 2020 as the date on which section 13(c) of the Act comes into operation: and
- (c) the 1st day of February, 2019 as the date on which sections 4(a)(iv) and 13(d) come into operation.
