ORDER

MADE BY THE PRESIDENT UNDER SECTION 8A(2) OF THE CUSTOMS ACT

THE COMMON EXTERNAL TARIFF (VARIATION OF DUTY)  
(NO. 4) ORDER, 2018

1. This Order may be cited as the Common External Tariff <sup>Citation</sup>  
(Variation of Duty) (No. 4) Order, 2018.

2. In this Order, where “Ex” is used in relation to an item number <sup>Interpretation</sup>  
under a heading listed in the First Column of the First Schedule to the  
Customs Act, that item number shall refer only to the corresponding  
goods described in the Second Column.

3. The rates of duty set out in the First Schedule to the Customs <sup>Variation of</sup>  
Act, in relation to the goods carrying the headings and descriptions <sup>duty in the</sup>  
listed below in the First and Second Columns respectively, are varied to <sup>First</sup>  
the amount specified in the Third Column for the period specified in the <sup>Schedule</sup>  
Fourth Column— <sup>Chap. 78:01</sup>
