2. In this Order "the Act" means the Criminal Procedure (Plea Interpretation Act No. 12 of Act No.

3. The Schedule to the Act is amended in Form 9 by-

- (a) deleting the words "and 30(2)";
- (b) deleting the words "a conviction or sentence (or order of rejection of plea agreement)" and substituting the words "an order of rejection of plea agreement";
- (c) deleting the words "conviction or sentence/", wherever they occur; and
- (d) deleting the words "in the case of appeal against conviction or sentence, list one or more of the grounds cited in section 30(1) in the case of appeal against order of rejection of plea agreement, give grounds" and substituting the words "state grounds".
