## ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2018

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Labour Day Celebrations—Fyzabad) Order, 2018.
- 2. This Order has effect between the hours of 6.00 a.m. and 12.00 Duration midnight on Tuesday 19th June, 2018.
  - 3. Parking is prohibited—

Parking prohibited

- (a) between the hours of 6.00 a.m. and 12.00 midnight, on—
  - (i) Fyzabad-Guapo Road, between Uriah Butler Avenue and Gowers Well Road;
  - (ii) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
  - (iii) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
  - (iv) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
  - (v) Lum Tack Hill;
  - (vi) Delhi Road, between Fyzabad-Oropouche Road and Mon Desir Delhi Road;
  - (vii) Fyzabad-Oropouche Road, between Fyzabad Junction and Avocat Junction;
  - (viii) Gowers Well Road, between Fyzabad-Guapo Road and Patterson Street;
  - (ix) John Jules Trace, between Delhi Road and Gowers Well Road; and
  - (x) Uriah Butler Avenue; and

- (b) between the hours of 6.00 a.m. and 12.00 noon, on—
  - (i) Siparia Old Road, between Avocat Junction and Samlal Trace; and
  - (ii) Fyzabad-Oropouche Main Road, between Avocat Junction and Jebodhsingh Street.

Vehicular traffic prohibited 4. Vehicular traffic is prohibited on Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction between the hours of 6.00 a.m. and 12.00 midnight.

Alternate routes

- 5. (1) A driver proceeding to Fyzabad from Oropouche along the Fyzabad-Oropouche Main Road shall proceed in a southeasterly direction at Avocat Junction onto Siparia Old Road, and proceed west onto Fyzabad-Guapo Main Road.
- (2) A driver proceeding to San Fernando or Point Fortin along Delhi Road, shall proceed northwest onto Mon Desir Delhi Road, and onto the Solomon Hochoy Highway Extension.
- (3) Between the hours of 11.00 a.m. and 12.00 midnight, a driver proceeding to Siparia along Delhi Road shall proceed south onto Khan Trace, west onto Winston Campbell Street, southeast onto Gowers Well Road, south onto Fyzabad-Guapo Road, east onto Uriah Butler Avenue and proceed in a southeasterly direction along Fyzabad-Guapo Road.

Removal and impounding of vehicles unlawfully parked 6. Without prejudice to any other liability incurred by the commission of a summary offence, a vehicle found parked in contravention of this Order may be removed by a police officer and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
