### TENDER FOR THE HIRE OF MECHANICAL EQUIPMENT/VEHICLES FOR THE MINISTRY OF WORKS AND TRANSPORT ON AN “AS AND WHEN REQUIRED” BASIS FOR A PERIOD OF ONE YEAR

TENDERS are invited for the Hire of Mechanical Equipment/Vehicles on an “as and when required” basis for the Ministry of Works and Transport for a period of one (1) year.

Tender documents can be obtained during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain. Telephone Numbers 625-3565 or 625-4330.

Tenderers are required to pay a tender deposit of one thousand dollars (\$1000.00) payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116, Frederick Street, Port-of-Spain. This deposit will be received from Monday to Friday between the hours of 9.00 a.m. to 12.00 noon and 1.00 p.m. to 3.00 p.m. The original receipt must be attached to the tender.

Tenders must be accompanied by the following:

- (a) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (b) valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original tender and a copy on the approved tender form should be placed in sealed envelopes clearly marked on the outside: “Tender for the Hire of Mechanical Equipment/Vehicles for the Ministry of Works and Transport on an “as and when required” basis for a period of one (1) year.

2. The 33<sup>rd</sup> Annual General Meeting of the Law Association of Trinidad and Tobago will be held on **Friday 22<sup>nd</sup> March, 2019 at 3:00 p.m.** in the **Convocation Hall, Hall of Justice, Knox Street, Port-of-Spain (other venues to be announced, if any).**
3. Nominations for the position of President, Vice President, Treasurer and fifteen (15) Ordinary Members (10 seniors and 5 juniors) must be made in writing on the prescribed Nomination Form. A separate nomination form is required for each position to be contested.
