FATF'S LIST OF JURISDICTIONS WITH AML/CFT DEFICIENCIES

NOTICE IS GIVEN that pursuant to Section 17(1) (a) of the Financial Intelligence Unit Act of Trinidad and Tobago Chap. 72:01, the Financial Intelligence Unit of Trinidad and Tobago is required to publish a list of countries identified by the Financial Action Task Force (FATF) as jurisdictions that have strategic antimoney laundering and counter financing of terrorism (AML/CFT) deficiencies.

AND NOTICE IS GIVEN that, the FATF's public statement dated October 18, 2019 identified the following jurisdictions as having strategic AML/CFT deficiencies and the measures which must be taken.

FATF PUBLIC STATEMENT ISSUED OCTOBER 18, 2019

A. JURISDICTIONS SUBJECT TO A FATF CALL FOR THE APPLICATION OF COUNTER-MEASURES AND ENHANCED DUE DILIGENCE MEASURES.

DEMOCRATIC PEOPLE'S REPUBLIC OF KOREA (DPRK)

The FATF calls on its members and urges all jurisdictions to advise their financial institutions to give special attention to business relationships and transactions with the DPRK, including DPRK companies, financial institutions, and those acting on their behalf. In addition to enhanced scrutiny, the FATF further calls on its members and urges all jurisdictions to apply effective counter-measures, and targeted financial sanctions in accordance with applicable United Nations Security Council Resolutions, to protect their financial sectors from money laundering, financing of terrorism and weapons of mass destruction (WMD) proliferation financing (ML/FT/PF) risks emanating from the DPRK.

IRAN

The FATF remains concerned with the terrorist financing risk emanating from Iran and the threat this poses to the international financial system until Iran implements the measures required to address the deficiencies identified in their Action Plan. The FATF, therefore, calls on its members and urges all jurisdictions to continue to advise their financial institutions to apply enhanced due diligence to business relationships and transactions with natural and legal persons from Iran, consistent with FATF Recommendation 19, including: (1) obtaining information on the reasons for intended transactions; and (2) conducting enhanced monitoring of business relationships, by increasing the number and timing of controls applied, and selecting patterns of transactions that need further examination.

Publication of Inactive Accounts

In accordance with the revised Financial Institutions Act 26 of 2008 by Central Bank:

Publication of Inactive Accounts

Section 76 (1): Every licensee shall, within sixty days after the end of its financial year, publish in the *Gazette* and in at least two daily newspapers published and circulated in Trinidad and Tobago a statement showing all accounts payable by the licensee in respect of which during a period of seven years or any longer period, no transaction has taken place and no statement of account has been requested or acknowledged by the creditor.

The following accounts have had no activity or requests for, or acknowledgement of, statements for the past seven (7) years or longer. The person to whom the account is payable or his legal personal representative must submit a claim to the licensee on or before 26th February 2020, to the respective branch to have the account returned to an active status. Failure to do so will result in the transferring of the account to the Central Bank of Trinidad and Tobago. The presentation of valid identification is required to complete this transaction.
