APPOINTMENT OF A PRIVATE WAREHOUSE (*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kathy Ann Matthews, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereunder to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the Private Warehouse of Messrs. Alstons Shipping Limited of, Ansa McAL Centre, Uriah Butler Highway and Rodney Road, Chaguana: Alcoholic beverages, various mixed groceries, household appliances, automotive machinery parts, electrical and mechanical equipment and parts, transshipment goods and ship stores and such other goods as I may subsequently approve.

SCHEDULE

An enclosed area measuring 36.58 meters by 12.34 meters comprising 451.40 square meters, constructed of concrete walls on the western and northern sides and BRC wire fencing on the southern and eastern sides with a galvanized roof. A further area adjacent to this area is included for a "Cool Room". This area has a wall of 12.19 metres on the northern side, a wall of 9.75 metres on the western side, an indentation abutting an office with a wall of 11.28 metres on the eastern side of the office, an indentation of 0.91 metres to the east, a wall of 3.35 metres on the eastern side of the office, a southern wall measuring 5.18 metres and a wall on the eastern side measuring 24.38 metres. This area comprises 200.67 square metres. The walls are made of concrete and the roof of galvanized sheeting.

The building is bounded on the north by the Standards Distributors Limited (building #9), on the south by the Guardian Media Limited, on the east by private residences (Lange Park) and on the west by the Uriah Butler Highway.
