THE Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) for the Project, Strengthening of the Single Electronic Window (SEW) for Trade and Business Facilitation. Funding received for the project shall be applied to the above mentioned Consultancy.

The Government of the Republic of Trinidad and Tobago (GORTT) as part of its national strategy in 2009, launched a Single Electronic Window (SEW) for Trade and Business Facilitation Project, branded as TTBizLink, an on premise infrastructure IT-based trade facilitation solution. After three (3) phases of development, and with more than six thousand, five hundred (6,500) registered users, TTBizLink currently hosts forty six (46) transactional e-services administered by twenty four (24) government agencies across nine (9) separate Ministries. This current on premise infrastructure will be migrated to a cloud based infrastructure by first quarter of 2019.

The Scope of Services for the Consultancy is to design and implement a customizable, modern, enhanced TTBizLink Application Software Solution with the objective of achieving improvements in cost efficiency, agility and innovation. The Consulting Firm is also expected to plan the migration of the current system to the new solution, within the existing legislative and operational framework for the single window of Trinidad and Tobago and ensure that the online system seamlessly integrates with all other relevant stakeholder systems.

In this regard, the Central Tenders Board (CTB), on behalf of the Executing Agency, the MTI, invites eligible consulting firm(s) to indicate their interest in providing the Consulting Services. Interested firm(s) must provide information to substantiate their ability to perform the Consulting Services. Submissions must include, at a minimum, a company profile inclusive of a signed transmittal letter and project summary of experience in similar projects (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills amongst staff, financial capability, etc.)
